**AMENDMENT TO DECLARATION OF CONDOMINIUM  
OF POWDERWOOD AT LANDMARK CONDOMINIUM**

This Amendment to Declaration of Condominium of Powderwood at Landmark Condominium is made and executed by the Powderwood Homeowners Association, of 6975 North 2200 West, Park City, UT 84098-8204 (the "Association").

**RECITALS**

A. The Declaration of Condominium of Powderwood at Landmark Condominium was recorded in the office of the County Recorder of Summit County, Utah on June 28, 1984 as Entry No. 222015 in Book 304 at Page 184 of the official records (the "Declaration").

B. The Association is the managing agent of all of the owners of the real property located in Summit County, Utah, described with particularity on Exhibit "A," attached hereto and incorporated herein by this reference (the "Property").

C. The Property is subject to the Declaration.

D. All of the voting requirements of Article III, Section 22 of the Declaration to amend the Declaration have been satisfied.

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Property and the owner thereof, the Association hereby executes this Amendment to Declaration of Condominium of Powderwood at Landmark Condominium.

1. Article III, Section 17 of the Declaration is hereby amended to add the following provision:

**Suspension of Common Utility Service.** If an Owner fails or refuses to pay any assessment when due, the Management Committee may, after giving written notice and an opportunity to be heard, suspend the Owner's right to receive utility services that are paid as a Common Expense. An Owner who is given notice of the Association's intent to suspend utility services may request an informal hearing to dispute the decision by submitting a written request for a hearing to be held within thirty (30) days from the date the notice is received. If a hearing is requested, utility services may not be suspended until after the hearing has been conducted and a final decision has been entered.

2. Article III, Section 17 of the Declaration is hereby amended to add the following provision:

**Suspension of Use of Recreational Amenities.** If an Owner fails or refuses to pay any assessment when due, the Management Committee may, after giving written notice and an opportunity to be heard, suspend the owner's right to use the recreational amenities. An Owner who is given notice of the Association's intent to suspend the Owner's right to use the recreational amenities may request an informal hearing to dispute the decision by submitting a written request to the Management Committee within thirty (30) days from the date the notice is received. If a hearing is requested, the right of access to and use of the recreational amenities may not be suspended until after the hearing has been conducted and a final decision has been entered.

3. Article III, Section 17 of the Declaration is hereby amended to add the following provision:

Any mortgagee who obtains title to a unit through foreclosure will be liable for up to six (6) months of the unpaid regularly budgeted assessments and the related collection costs and attorney's fees.

4. Article III, Section 17 of the Declaration is hereby amended to add the following provision:

**Collection of Rents.** If an Owner is renting his or her unit and fails to pay the amount of any assessment due for a period of more than sixty (60) days after it is due, the Management Committee may deliver written notice to the Owner and renter demanding that future rents be paid to the Association. Within five (5) business days of payment in full of the assessments, including any interest or late

fees, the Management Committee shall notify the owner and renter in writing that future rent payments are no longer due to the Association.

5. In the event of any conflict, incongruity, or inconsistency between the provisions of the Declaration and this Amendment, the latter shall in all respects govern and control.

6. The effective date of this Amendment is the date it is recorded in the office of the County Recorder of Summit County, Utah.

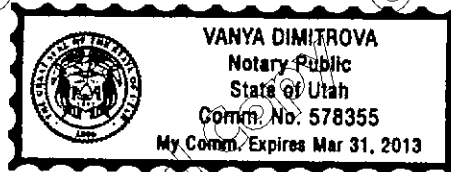
