RECITALS

A. Scandia Village (the "Project") is a condominium  
project located in the City of Provo, County of Utah, State of  
Utah.

B. On \_\_\_\_\_, 1992, Declarant caused to be recorded the  
Declaration of Condominiums, Scandia Village Condominiums, [A  
Condominium Project (Expandable)] in Book \_\_\_\_\_ at Page \_\_\_\_\_, as  
Entry No. \_\_\_\_\_ in the Office of the Recorder, Utah County, State of  
Utah (the "Declaration").

C. Pursuant to the Utah Condominium Ownership Act and Article 13.5  
of the Declaration, Declarant is entitled to annex into the Project  
the real property referred to in the Declaration as "Additional Land,"  
in Exhibit "B," thereto.

D. Declarant is the record owner of the Additional Land and desires  
to annex a portion of the same into the development to become subject  
to the Declaration and to the Act.

E. There currently exist in the Project Four (4) Units in One (1)  
Building. This First Supplementary Declaration and the Scandia  
Village Condominium Phase II map to be recorded concurrently herewith,  
expands the Project to include Four (4) additional Units in One (1)  
additional Building.

NOW THEREFORE, Declarant hereby makes this First Supplementary  
Declaration:

ARTICLE I  
DEFINITIONS

Except as otherwise may be defined herein or as may be required by the  
context, all terms, phrases or expressions defined in Article I of the  
Declaration shall have the same defined meanings when used in the  
First Supplementary Declaration, including Recitals.

ARTICLE II  
SUBMISSION

Declarant hereby submits to the provision of the Act, as Additional  
Land associated with the Project, that certain parcel of real property  
situated in Utah County, State of Utah, described in Exhibit "A,"

attached hereto and made part hereof, as the same is set forth in that certain Map entitled "SCANDIA VILLAGE CONDOMINIUMS PHASE II" filed and recorded concurrently herewith in the Office of the Recorder, Utah County, State of Utah.

ARTICLE III  
PROPERTY RIGHTS

Exhibit "D" to the Declaration is hereby amended as set forth in Revised Exhibit "D," attached hereto and made a part hereof, which Exhibit reallocates the undivided interests in the common areas of each Owner appurtenant to each such Owner's Unit, which interests are equal and in the percentages of fraction set forth in said Exhibit "D" hereto.

ARTICLE IV  
GENERAL

Except as modified and amended by this First Supplementary Declaration, all of the terms and provisions of the Declaration are hereby expressly ratified and confirmed and shall remain in full force and effect and shall apply to the Project as expanded.

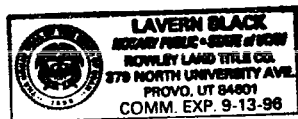

SCANDIA VILLAGE PHASE II  
PROVO, UTAH

Commencing at a point located North 393.60 feet and West 1272.10 feet and North 73.00 feet from the Southeast Corner of Section 7, Township 7 South, Range 3 East, Salt Lake Base and Meridian; thence North 51.42 feet; thence East 146.20 Feet to the Westerly Right-of-Way line of 1000 East Street; to the point of a 222.00 foot radius curve to the right.
