Thence North forty two degrees and forty five minutes West, (N 42°-45' W) twenty (20) rods; thence North twenty-seven degrees and thirty minutes West, (27°-30' W) twenty four (24) rods; thence North thirty-two degrees West (N 32° W) forty-four (44) rods; thence North thirty eight degrees West (N 38° W) eight (8) rods; thence East fifty two and two tenths (52.2) rods to the North East corner of the South East quarter of the South West one quarter of said Section; thence South eighty (80) rods to beginning. The South East one quarter (1/4) of the South West one quarter (1/4) of Section Numbered Twenty One (21) in township Numbered three (3) South of range Numbered one (1) West of the Salt Lake Meridian; The grantee herein to maintain the said line where the same is now constructed over and across the above described tract of land. If in the future it shall become necessary to replace a pole or make other actual repairs in said line and the grantee or its employes enter upon said tract and trample down and destroy growing crops or fences, then in that event the owners of said line shall pay unto the owner of said tract the actual value
