RIGHT OF WAY GRANT

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, South Jordan Canal Company is the operator of the South Jordan

Canal and specifically that portion of the canal situated in the county of Salt

Lake, State of Utah, described as follows:

Beginning at a point on the West line of 2700 West Street said point is South 89°58'11" West along the Section line 50.00 feet and North 0°14'53" West 53.00 feet from the South Quarter corner of Section 9, Township 2 South, Range 1 West, Salt Lake Base and Meridian, and running thence South 89°58'11" West along the North line of 5400 South Street 12.93 feet thence North 43°13' West along the West edge of the South Jordan Canal 201.59 feet; thence North 89°58'11" East 19.47 feet to a point on the East edge of the South Jordan Canal; thence South 43°13' East along the said East edge of said canal 191.99 feet to a point on the West line of 2700 West Street; thence South 0°14'53" East along said West line 7.00 feet to the point of beginning.

WHEREAS, Phillips 66 Company is desirous of obtaining a right-of-way over the property described above:

NOW THEREFORE, for value received, South Jordan Canal Company does hereby grant to Phillips 66 Company an easement over the above-described real property for the purpose of ingress and egress to property owned by Phillips 66 Company.

It is understood drawings and specifications for said crossing have been submitted to and approved by the Board of the South Jordan Canal Company.

Further, it is understood plans and specifications for the conveyance of water through the above-described real property have been submitted to and approved by the Board of the South Jordan Canal Company.

Phillips 66 Company, its successors in interest or assigns have the continuing responsibility to maintain any crossing for ingress and egress and to protect and hold harmless the South Jordan Canal Company from any and all liability or loss occasioned by any break in or failure to maintain any crossing for purposes of ingress and egress over the above-described real property.

Phillips 66 Company, its successors in interest or assigns have the continuing responsibility to protect against any obstruction in flow of waters through the canal as above-described.

To prevent disturbance in use of the canal, any construction contemplated by Phillips 66 Company, its successors in interest or assigns must be commenced and completed during the period from October 15 through April 1 unless written permission is obtained from the President of the South Jordan Canal Company.

The South Jordan Canal Company and Phillips 66 Company each agree that should they default in any of the covenants or agreements contained herein, that the defaulting party shall pay all cost and expenses including reasonable attorney fees which may arise or accrue from enforcing this Agreement, or in pursuing any remedy provided hereunder or by the statutes of the State of Utah whether such remedy is pursued by filing suit or otherwise.

It is understood that this Agreement constitutes the entire agreement between the parties and shall not be altered or modified by any prior or subsequent oral agreements.
