1 L. Lorraine Bagley, being first duly sworn, upon oath, deposes and says:  
2 That he is a citizen of the United States, a resident of Salt Lake City,  
3 Utah, over the age of 21 years.

4 That he is the person who, as L. L. Bagley executed, in conjunction  
5 with his wife Elaine A. Bagley, that certain warranty deed dated September 19, 1921  
6 recorded September 19, 1921 in Book 11-K, pages 169-70 Salt Lake County Recorder's  
7 Records, in which Hazel C. Oleson is named as grantee, covering said property in  
8 Salt Lake County more particularly described in said warranty deed. That said  
9 deed recited that it was made subject to a mortgage of \$800.00 due two years after  
10 date which grantee assumed and agreed to pay.

11 That affiant is the same person as L. Lorraine Bagley named as grantee  
12 in that certain warranty deed wherein Sam A. Oleson and Hazel Clark Oleson appear  
13 as grantors, which deed was dated November 13, 1922 recorded November 15, 1922  
14 in Book 11-S pages 151-2, Salt Lake County Recorder's records which deed covered  
15 property more particularly described therein represented by the same mortgage re-  
16 ferred to in the deed dated September 19, 1921, last hereinbefore mentioned; that  
17 affiant knows of his own knowledge that no mortgage of \$800.00 was ever made on  
18 said property although referred to in said two deeds; that it had been the in-  
19 tention of grantors and grantees in said two deeds that a mortgage would be exe-  
20 cuted on the property but such was never made and never existed and therefore  
21 never became a lien thereon.

22 Affiant knows of his own knowledge that the person named L. L. Bagley, <sup>grantor,</sup>  
23 in the aforementioned deed dated September 19, 1921 and L. Lorraine Bagley named  
24 as grantee in the aforementioned deed dated November 13, 1922 was one and the same  
25 person whose real and true name was and is L. Lorraine Bagley.

26 Affiant knows of his own personal knowledge that Hazel C. Oleson grantee  
27 in the aforementioned deed dated September 19, 1921 and Hazel Clark Oleson one  
28 of the grantees named in the aforementioned deed of November 13, 1922 is and was  
29 one and the same person whose real and true name was and is Hazel Clark Oleson.

30 That L. L. Bagley and L. Lorraine Bagley who appears as one of the  
31 parties in various instruments affecting the title to property hereinafter des-  
32 cribed is one and the same person whose real and true name is L. Lorraine Bagley.

33 That affiant knows of his own knowledge that W. B. Smith, who retained
