NOW THEREFORE: pursuant to the requirements of Section 17A-2-332 Utah Code Annotated, 1953 as amended, the Board of County Commissioners of Weber County does hereby declare that the public health convenience and necessity require the annexation of the property described in Attachment A into the Central Weber Sewer Improvement District and the Board of County Commissioners hereby annexes the property described in Attachment A into the Central Weber Sewer Improvement District.
