**AMENDED AND RESTATED
DECLARATION OF PROTECTIVE COVENANTS**

This Amended and Restated Declaration of Protective Covenants (the "Amended Declaration") is made this 17th day of APRIL, 2007 by the undersigned who are a majority of the owners of the Property (as hereafter defined) to replace and supercede the Original Declaration, as hereafter defined.

RECITALS:

WHEREAS, a declaration dated August 15, 1955, prepared by Bonnie Development Company was recorded November 16, 1955 as Entry No. 1456070 in Book 1258 beginning at Page 229 of the official records of the Salt Lake County Recorder, as amended by the Amendment to Restrictions recorded December 2, 1955 as Entry No. 1458689 in Book 1263, Page 426 and as further amended by the Amendment to Restrictive Covenants of Mount Olympus Acres No. 7, dated February 26, 1979 and recorded March 26, 1979 as Entry No. 3255243 in Book 4834 at Page 299, all in the official records of the Salt Lake County Recorder (the "Original Declaration"); and

WHEREAS, the Original Declaration pertained to and affected all of the following property located in Salt Lake County, Utah (the "Property"):

ALL OF LOTS 701 to 737, inclusive, MOUNT OLYMPUS ACRES, NO. 7, part of a subdivision, according to the official plat thereof on file and of record in the office of the Salt Lake County Recorder of the State of Utah.

WHEREAS, the undersigned, representing a majority of the owners of the various lots in the Property, now desire to further clarify, supplement, restate and amend the Original Declaration, as herein provided.

NOW, THEREFORE, the undersigned hereby subject the Property to the following protective covenants, restrictions and conditions:

1. Residential Lots. All of the lots in the Property shall be known and described as residential lots. No structure shall be erected, altered, placed or permitted to remain on any residential building lot other than one detached single-family dwelling, not to exceed one story in height from the street elevation, and a private garage for no more than three (3) automobiles.
2. Set Back Requirements. No building shall be located on any residential building lot nearer than 30 feet from the front lot line or nearer than 30 feet from any side street or nearer than 12 feet from any interior lot line. The side yard interior minimums do not apply to a garage detached and located in the rear of any residence. No dwelling shall be erected, placed or constructed on any lot having a width of less than 100 feet at the minimum building setback line.
3. Out Buildings. No trailer, basement, motor home, recreational vehicle, tent, shack, garage or other out-building erected on any part of the Property shall at any time be used as a residence temporarily or permanently, nor shall any residence of a temporary character be permitted.
4. Design Review Committee. A Design Review Committee (the "Committee") representing the owners of the Property shall exist, consisting of five (5) members. The initial Committee members shall be Jay Layton, Janet Hutchinson, Joyce Barnes, Daniel Liston and Anne Decker. The members of the Committee shall serve without compensation and shall serve until they have been replaced by a successor, moved away from the Property or become deceased. A Committee member must be a resident in the Property. In the event of any vacancy on the Committee, a replacement member of the Committee shall be made by unanimous appointment of the remaining Committee members. In the event no unanimous choice can be agreed upon, the new Committee member shall be selected by two-thirds (2/3) of the lot owners in the Property. The Committee shall be bound by the covenants set forth in this Amended Declaration and will not be allowed to approve material exceptions that are not in harmony with a majority of the existing structures in the Property.
5. Voting. For purposes of voting, there shall be one (1) vote per lot in the Property, regardless of the number of owners of said lot. In such event of multiple owners of a single lot, a majority of the ownership interest in the lot shall be entitled to cast the vote for said lot. If, during any vote, the majority of multiple owners of a lot cannot agree on how to vote, no vote will be cast on behalf of said lot for said vote.
6. Moving Structures Onto Lots. No structure shall be moved onto any lot unless it meets with the approval of the Committee. In the event the Committee should not be in

existence, such structure shall conform with all the covenants set forth in this Amended Declaration and be in harmony with a majority of the existing structures in the Property.

7. Committee Approval of Construction. No building or other improvements shall be erected on any lot until the design and location thereof have been approved in writing by the Committee. In any case, no dwelling shall be permitted in the Property with a total square foot area of more than 6,500 square feet not including garage. Additionally, no dwelling shall be permitted in the Property with the ground floor square foot area of less than 1500 feet, if the structure contains an attached garage, nor less than 1700 square feet if the structure does not contain an attached garage, provided, however, that with respect to lots 701 to 705, inclusive, 707, to 711, inclusive, lots 712, 719, 720, 731, and 732, no dwelling shall be permitted with a total square foot area of more than 5,200 square feet not including garage or with the ground floor square foot area of less than 1250 square feet if the structure includes an attached garage or less than 1350 square feet without such attached garage.

8. No Lot Subdivisions. No lot in the Property may be further subdivided. No boundary line adjustment of any lot in the Property may be made without the prior written approval of three-fourths (3/4) of the lot owners in the Property, on the basis of one vote per lot.

9. Lot 722. It is covenanted and understood that Lot 722 in the Property was previously zoned C-2 by the Salt Lake County Commission and the current owners and all future grantees of said lot accept title such that said zoning shall be a covenant running as a burden against said lot.

10. No Livestock. No provision shall be made on any dwelling lot for the raising of poultry or the housing of cows, horses or other livestock except with the prior written approval of the Committee.

11. Covenants Run With the Land. The covenants and restrictions herein shall run with the land and shall be binding on the parties hereto and all persons claiming under them.

12. Duration and Renewal. This Amended Declaration and every covenant contained herein shall be in effect for a period of twenty-five (25) years from and after the date hereof, and shall automatically be continued and renewed thereafter, for successive periods of ten (10) years each.

13. Further Amendments. Any further amendments to the covenants, conditions and restrictions set forth in this Amended Declaration shall require a three-fourths (3/4) vote of all of the lots in the Property, on the basis of one vote per lot.

14. Right of Enforcement. The owner of any lot in the Property shall have a right and standing, after ten (10) days prior written notice, to seek enforcement of this Amended Declaration in a court of competent jurisdiction. In such event, the owner of any lot that is found to be in violation of this Amended Declaration shall be obligated to pay all costs and reasonable attorneys' fees incurred by any lot owner(s) who shall seek enforcement of this Amended Declaration.

15. Unauthorized Excavation and Disturbance. In the event of any excavation or disturbance of the soil or other improvements on any lot, which is in violation of any condition, covenant or restriction of this Amended Declaration, the owner(s) of said lot shall be obligated to restore the said lot to the same condition said lot was in prior to such excavation or disturbance.

16. Miscellaneous Provisions.

(a) Invalidation and Severability. Invalidation of any one of these covenants by judgment or court order shall not affect any of the other provisions which shall remain in full force and effect.

(b) Paragraph Headings. Paragraph headings are inserted for convenience only and are not intended to be a part of this Amended Declaration or in any way to define, limit, or describe the scope or intent of the particular paragraph to which they refer.
