

Beginning at a point North 00°27'32" West 1870.391 feet along the Quarter Section line and West 596.363 feet from the Center of Section 25, Township 1 North, Range 1 West, Salt Lake Base and Meridian and running thence South 45°57'11" West 547.166 feet to the northeasterly line of Beck Street; thence North 43°46'53" West 194.592 feet along said northeasterly line according to Salt Lake City Corporation Survey No. 1042, dated 10/6/87, filed in the Salt Lake City Engineer's Office; thence North 46°09'00" East 424.285 feet along the northwesterly line of the Little America Hotel Corporation property described in Correction Quit-Claim Deed recorded April 14, 1982 as Entry Number 3666139, Book 5362 Page 96 of the Salt Lake County Recorder's Office; thence South 79°14'00" East 121.770 feet along a southwesterly line of the Pinshon Properties, LLC property as described in Correction Warranty Deed recorded 10/5/2000 as Entry Number 7733644, Book 8392 Page 7236 of the Salt Lake County Recorder's Office; thence Southeasterly 107.465 feet along said southwesterly line, also being a 331.220 foot radius non-tangent curve to the right, from which the radius point bears South 07°41'40" West (delta = 18°35'23" and long chord bears South 73°00'38" East 106.995 feet); thence South 45°57'11" West 547.166 feet to the point of beginning.
