ADDENDUM #4 TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF THE MARQUIS AT SOUTHTOWNE

THIS ADDENDUM #4 TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF THE MARQUIS AT SOUTHTOWNE, is executed this 2 day of July, 2007.

This Addendum #4 is hereby incorporated as part of the Declaration of Covenants, Conditions and Restrictions of the Marquis at Southtowne ("Declaration"), which was originally recorded on September 21, 1999, Book 8310, Page 5262, #7470876. The following Addendum creates Article X, Section 20 of said Declaration. All other sections of said Declaration remain binding and in full force. This Addendum #4 shall be binding on, and applicable to, Units 1 through 18 and the common areas of the Marquis at Southtowne, parcel no. 27-14-254-001 through -019.

ARTICLE X - GENERAL USE RESTRICTIONS

- 20. <u>Parking Restrictions and Penalties</u>. The Association shall be responsible for promogating rules regarding parking and penalties for violating said rules as it deems necessary. Because of extreme parking problems, the Association has directed the Association Manager to proceed as follows:
 - a. Handicap parking signs should be installed and handicap parking spaces shall be denoted and painted as necessary.
 - b. That the no parking zones / curbs shall be painted/denoted.
 - c. That each unit shall be assigned 2 parking spaces, which may be used by the owner of each unit either for customer parking or for other designated parking. Parking signs shall be installed. Each unit is to pay for the parking signs to designate its reserved spots.
 - d. The Association shall enforce the current parking regulations, specifically the Association shall boot or tow any violating vehicles improperly parked in the handicap parking spaces, in the no parking zones / curbs or in the designated parking spots.
 - e. That the Association Manager shall hire a towing company to boot or tow away

the offending vehicles.

f. The Association Manager shall also have the authority to contact the South Jordan City Police to impound and/or tow the vehicles parked in violation of these rules.


