## GRANTOR'S WARRANT

## WARRANT DATED

LEONPA S. PHILLIPS, Grantor of St. George, County of Washington, State of Utah,  
hereby CONVEYS and WARRANTS to EL PAGE'O LTD., a Corporation

, Grantee

of St. George, County of Washington, State of Utah, for the sum of Ten (\$10.00)  
Dollars and other adequate consideration, the following described tract of land  
situate in Washington County, State of Utah, to-wit:

Beginning at a point South 1805 feet from the West quarter  
corner of Section 11, in Township 12 South, Range 16 West,  
Salt Lake Meridian, and running thence East 232.5 feet; thence  
South 12° 15' West 150.7 feet; thence West, 200 feet; thence  
North 150 feet, more or less; to the place of beginning, and  
containing 0.74 acre, be the same more or less;

Together with all improvements thereon and all  
appurtenances thereto belonging, including a right of ingress  
to and egress from the same over a roadway to be designated  
by the Grantor, and subject to all existing roads, easements,  
and rights of way.

Together, also, with a right to use such water from  
the springs now owned by the Grantor in said area, for stock  
watering and domestic purposes only, as shall be reasonably  
required by the Grantee and upon such limitations and pur-  
suant to such regulation as the Grantor shall from time to time  
prescribe. The use of such water by the Grantee shall be  
conditioned upon his paying therefor the regular prevailing  
rate for culinary water fixed by the City of St. George, the  
minimum charge therefor to be paid by the Grantee annually,  
in advance, on the 1st day of September of each year, beginning  
with the first day of September, 1956, and any charge for  
excess water used by the Grantee shall be paid at the beginning  
of each succeeding September. The Grantee shall pay to the  
Grantor a connecting fee of \$50.00 for each connection made  
to the pipeline of the Grantor and in the event more than one  
acre of land is serviced from said connection, the further  
sum of \$50.00 shall be paid for each acre of land in excess  
of the first acre or fraction thereof. It is a further under-  
standing and condition of this grant of right to use said  
water that the Grantor shall have the right, at her election  
and expense to install a meter on the facilities from which  
the said Grantee draws water from said Springs. The Grantee shall  
be responsible for the installation of any facilities required to  
convey said water to said property herein described and he is  
hereby granted a right of way for a pipeline for the purpose of  
conveying the same, if necessary, said pipeline to be installed  
at a depth and in such manner and connected to the main line of  
the Grantor in such manner as the Grantor shall designate and  
prescribe.
