to PacificCorp, an Oregon corporation, dba Utah Power & Light
Company, whose principal place of business is located at 1407
West North Temple, Salt Lake City, Utah, its successors in
interest and assigns, Grantee, for the sum of Ten (\$10.00)
Dollars and other valuable consideration, a perpetual easement
and right of way for the erection, operation, maintenance,
repair, alteration, enlargement, inspection, relocation and
replacement of electric transmission and distribution lines,
communications circuits, fiber optic cables and associated
facilities, and 1 (one) 3 pole structure, 1 (one) pole and 5
guy anchors, with the necessary poles and guy anchors, stubs,
crossarms, braces and other attachments affixed thereto, for
the support of said lines and circuits, on, over, under and
across real property located in Davis County, Utah, described
as follows:

Beginning at a point on the south boundary
line of the Grantor's land said point also being the
northwest corner of Marvins Subdivision No. 1 said
corner being S.89°59'21"W. 636.66 feet along the
quarter section line and N.0°00'39"W. 330 feet from
the center of Section 27, T. 5N., R. 2W., S.L.M., and
running thence N.89°59'21"E. 317.00 feet, thence
N.0°00'39"W. 50.00 feet, thence S.89°59'21"W. 317.00
feet, thence S.0°00'39"E. 50. feet to the point of
beginning; containing 0.364 of an acre.

occupation and enjoyment of the easement hereby granted, and
all rights and privileges incident thereto, including the right
to cut and remove timber, trees, brush, overhanging branches

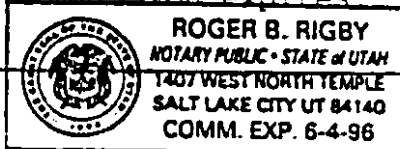
