This document is made and executed this 6th day of March 2008. For the record, and the purpose of this affidavit, this document will clarify street nomenclature for properties shown on Exhibits "A" & "B".

Historically, "Millcreek Canyon Road", as shown on Exhibit "A", begins at Wasatch Blvd., thence travels Southeasterly to the 4-way stop intersection (thence begins the entrance to Millcreek Canyon State Park). Here, the street name "Millcreek Canyon Road" continues east. Over time during the development of the neighborhood in this area, the street name "Millcreek" (dropping "Canyon") has typically been used in both the location and mailing addresses of residents along this stretch of road. Therefore, we are making the street name change official; "Millcreek" will replace Millcreek Canyon". All street signs will be replaced to reflect "Millcreek" Rd.


