The purpose for this affidavit is to change the recorded address for the lots listed below.

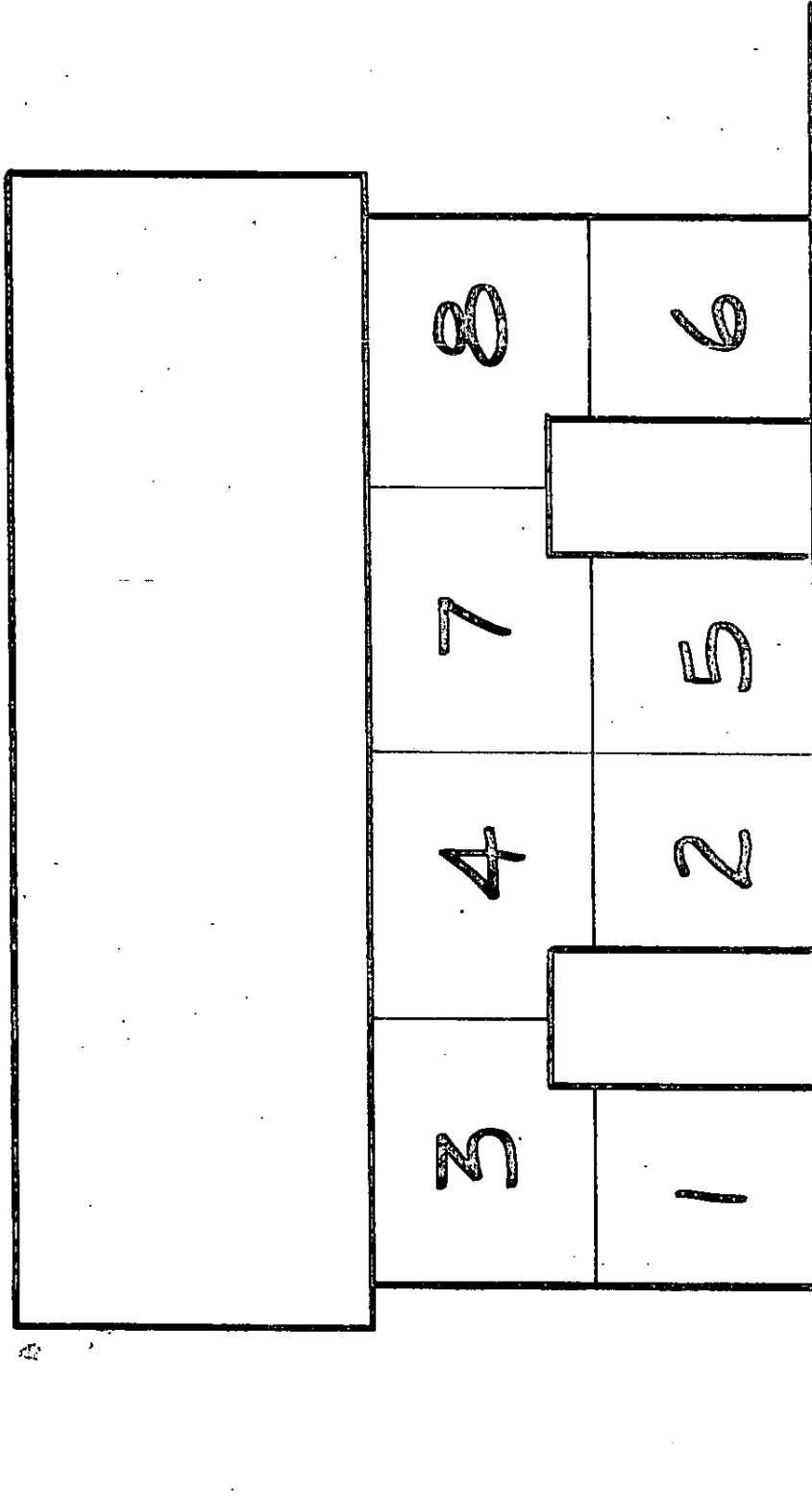





COTTONWOOD HILLS NUMBERING

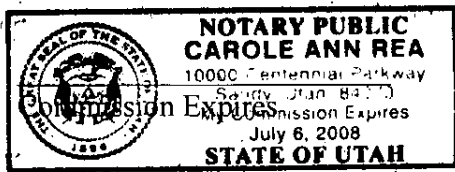


