Further, WaterPro, Inc., will only repair or restore the subject property at its expense as required by Utah Code Ann § 54-3-27, and will not rebuild or pay for the repair, replacement, or damage to patios, driveways, walls, personal property, fixtures, improvements, ponds, pools, concrete, asphalt, garages, sheds, structures, or other improvement that interferes with WaterPro, Inc's easement rights.

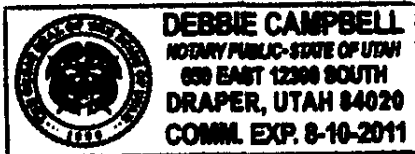
