A perpetual slope easement for the purpose of constructing, repairing and maintaining fill slopes and appurtenant parts or structures thereof adjacent to the south line of 9400 South Street, affecting a portion a parcel of land being identified as a portion of Lot 35, WHITE CITY No. 29 SUBDIVISION and by tax identification number 28-08-226-001, situate in the Northeast Quarter of Section 8, Township 3 South, Range 1 East, Salt Lake Base and Meridian. Beginning at a point on the south line of 9400 South Street, said point lies South 38°55'14" East 29.18 feet from the Northernmost Corner of Lot 35, WHITE CITY No. 29 SUBDIVISION according to the official plat thereof found as Entry No. 2477014 in Book MM of Plats at Page 15 in the office of the Salt Lake County Recorder, said point also lies North 89°21'10" West 1259.99 feet along the section line, South 0°17'52" East 33.00 feet and South 38°55'14" East 29.18 feet from the Northeast Corner of Section 8, Township 3 South, Range 1 East, Salt Lake Base and Meridian; thence along the easterly line of said Lot 35, South 38°55'14" East 12.98 feet; thence North 89°21'10" West 26.32 feet to intersect the westerly line of said Lot 35; thence along said westerly line, North 0°17'52" West 10.00 feet; thence South 89°21'10" East 18.22 feet to the point of beginning.
