**AMENDMENT TO THE SECOND AMENDED AND RESTATED DECLARATION OF  
CONDOMINIUM AND BYLAWS FOR CEDAR POINTE**

**This Amendment to the Second Amended and Restated Declaration of Condominium and Bylaws is made this 18th day of April, 2008 by the Cedar Pointe Owners Association, Inc., (the "Association").**

RECITALS

A. The Second Amended Declaration of Condominium was recorded on April 12, 2000, in the Salt Lake County Recorders Office as Entry 7616291, as amended and supplemented (the "Declaration").

B. This amendment shall amend the Declaration and Bylaws as noted below and shall apply to the lands described in Exhibit "A" and shall be binding against all of the property described in the Declaration and any annexation, expansion or supplement thereto;

C. Pursuant to Article III, Section 21 of the Declaration, at least sixty percent (60%) of all the Percentage Interests of the Unit Owners have approved this amendment.

**NOW, THEREFORE**, the Association hereby amends the following sections of the Declaration, to read as follows:

**Article III, Section 15 of the Declaration shall be amended in its entirety to read as follows:**

15. Manager. The Committee may carry out any of its functions which are capable of delegation through its Manager. Any Manager retained for such purposes must be an individual or entity experienced and qualified in the field of property management. The Manager so engaged shall be responsible for managing the Project for the benefit of the Unit Owners and shall, to the extent permitted by law, the terms of the agreement with the Committee, and as directed by the Committee, be authorized to perform any of the functions or acts required or permitted to be performed by the Management Committee itself. The Committee may solicit bids, interview, and recommend a Manager to the owners. The Owners by majority vote shall approve or reject the Committee's selection of Manager. If the Committee desires to terminate the Manager, it shall first obtain a majority vote of the Owners approving the termination of the Manager.

**Article III, Section 16, first sentence of the Declaration shall be amended to read as follows:**

The Committee shall be composed of five (5) to nine (9) members, as determined by majority vote of the Percentage Interests of all Owners.

**Article III, Section 2, first sentence of the Bylaws shall be amended to read as follows:**

The Committee shall be composed of five (5) to nine (9) members, as determined by majority vote of the Percentage Interests of all Owners.

**Article III, Section 6, of the Bylaws shall be amended to read as follows:**

6. Committee's Quorum. At all meetings of the Committee, a majority of the Committee persons shall constitute a quorum for the transaction of business, and the acts of the majority of the Committee persons present at a meeting at which a quorum is present shall be the acts of the Committee. If, at any meeting of the Committee, there be less than a quorum present, the majority of those present may adjourn the meeting from time to time. Any adjourned meeting shall not reconvene for at least three (3) days. Notice of an adjourned meeting shall be given to all Committee members. At any such adjourned meeting, any business which might have been transacted at the meeting as originally called may be transacted without further notice.

IN WITNESS WHEREOF, CEDAR POINTE OWNERS ASSOCIATION, INC., by and through its Management Committee, has executed this Amendment to the Declaration as of the 18<sup>th</sup> day of April, 2008, in accordance with Article III of the Declaration.

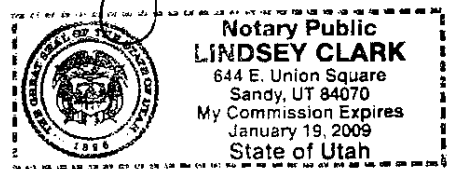
