including a reconveyance hereof.

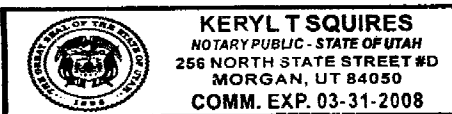


