\_\_\_\_\_ hereinafter called the Grantee, the receipt of which is hereby acknowledged, does hereby grant to the said Grantee, his (their, its) heirs, executors, administrators, successors and assigns the right to erect, construct, install and lay and thereafter use, operate, inspect, repair, maintain, replace and remove a 4" iron pipe line together with all accessories

upon, over, under and across the following described lands owned by the Grantor, lying in Utah County, State of Utah to-wit:

together with the right of ingress and egress for the purposes for which the above mentioned rights are herein granted.

The Grantor (and each of them) covenants to and with the Grantee that he is the owner of said tract and that the same is free from encumbrances except as follows:

and that he will, and his heirs, executors, administrators, successors, and assigns shall and will forever defend the said premises against the lawful claims and demands of all persons whomsoever except those above specified.

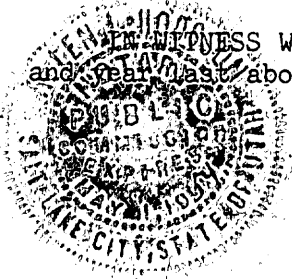
