OWNER'S DEDICATION

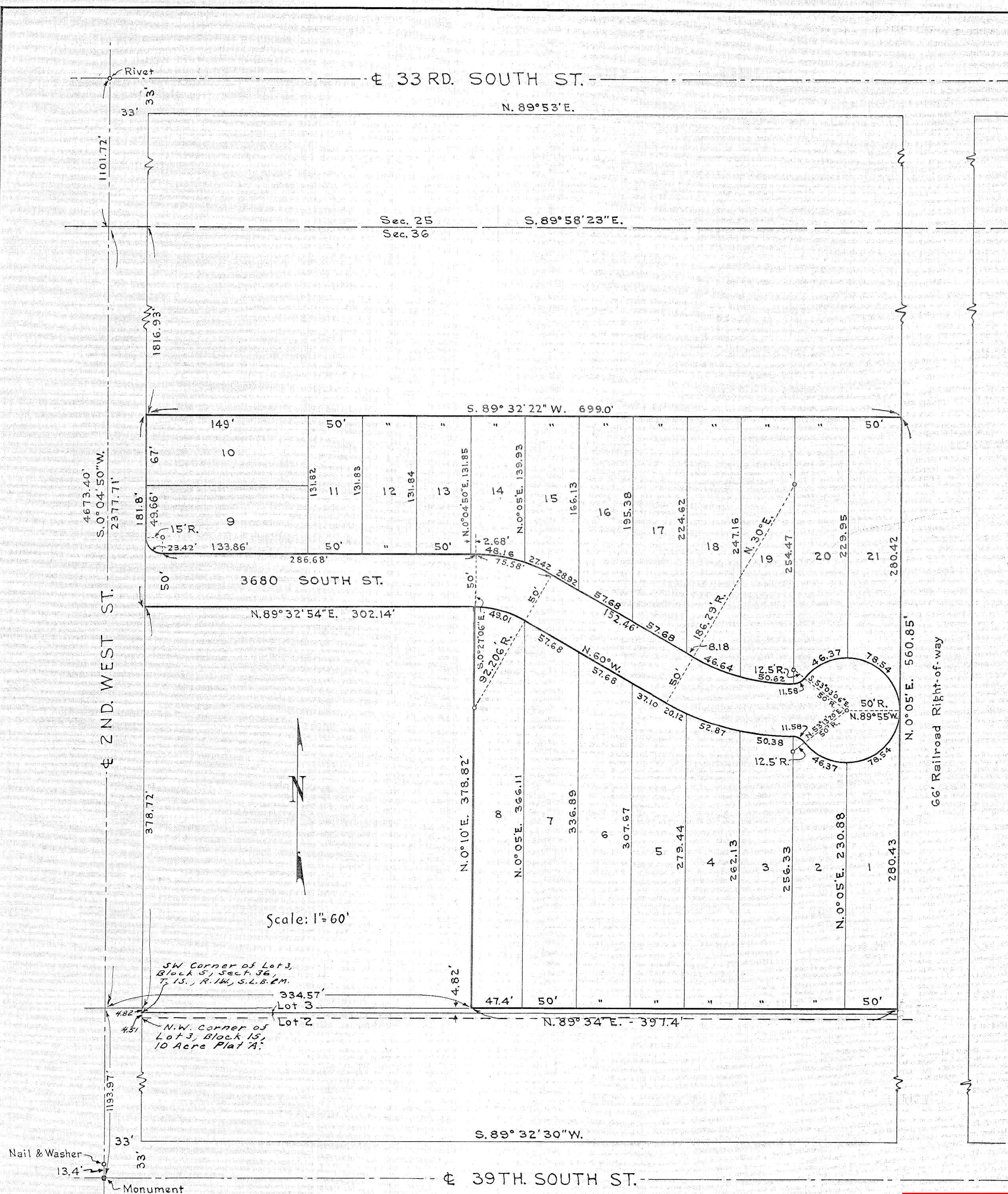
