Proposed Modification:

Delores Wilson and Centre Pointe Plaza propose that the future access near the middle of the property at about 6575 south and Redwood Road (Access A) and heads east toward mentioned property to be blocked by a concrete fence that Centre Pointe Plaza is installing to ensure our privacy. The current ROW is owned by Delores Wilson and the following parties listed below have an access agreement.
