TRANSPORTATION, at 4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for
the sum of Ten Dollars

A Perpetual easement, upon part of an entire tract of property situate in the SE1/4NW1/4 of Section 10, T. 4 S, R. 1 W, S.L.B. & M. for the purpose of constructing walls and wall straps, cut and/or fill slopes, and appurtenant parts thereof to facilitate the construction of State Route 68 known as Project No. 0068, The Easement includes the right to maintain and continue the existence of said walls and wall straps, and cut and/or fill slopes in the same grade and slope ratio as constructed by UDOT. The Easement shall run with the Real Property and shall be binding upon the Grantor and the Grantors successors, heirs and assigns, and includes and conveys all rights of grantor to change the vertical distance or grade of said cut and/or fill slopes. The boundaries of said parts of the entire tract are described as follows:

Beginning at a point on the south line of said entire tract, which is 245.64 ft. perpendicularly distant westerly from the centerline of said project No. 0068, opposite Engineer Station 993+04.85; which point is 636.01 ft., N. 89°51'06" W., along the North line of said NW1/4, and 1,363.86 ft. S. 00°08'54" W., from the North Quarter corner of said Section 10; and running thence S. 01°02'18" W., along said south line, 8.00 ft.; thence N. 86°07'15" W., 82.74 ft. to the north line of said entire tract; thence N. 00°24'00" E., along said north line 5.58 ft.; thence S. 89°56'39" E., 36.47 ft. to a point 290.33 ft perpendicularly distant westerly from the centerline of said project No. 0068, opposite Engineer Station 992+92.48; thence S. 86°06'10" E., 46.30 ft. to the point of beginning

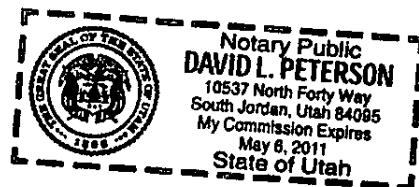
