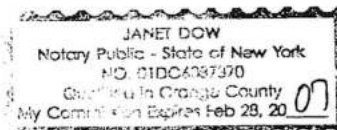

Beginning at a point 973.76 feet South and 536.98 feet West of the Northeast Corner of the Southwest Quarter of Section 13, T13S, R9E, SLBM; and running thence North 85 degrees 14' East 88.24 feet; thence North 7 degrees 16' West 131 feet, more or less, to the South line of the Romano tract as described in that certain Warranty deed recorded January 13, 1965, in Book 98 at page 592; thence South 85 degrees 14' West 88.24 feet; thence South 7 degrees 16' East 131 feet, more or less, to the point of beginning.
