
KNOW ALL MEN BY THESE PRESENTS:

That Wasatch Oil Refining Company, a Utah corporation having its principal office at Salt Lake City, Utah, and having an operating office at Bartlesville, Oklahoma, Grantor, hereby conveys and warrants to Phillips Pipe Line Company, a Delaware corporation having a valid and subsisting permit to do business in the State of Utah and having an operating office at Bartlesville, Washington County, Oklahoma, Grantee, for the sum of \$2,043.63, all of the following described property, to wit:

The entire crude oil pipe line system of Grantor located in Sections 23 and 24, Township 2 North, Range 1 West of the Salt Lake Meridian, Davis County, Utah, being approximately 1243 feet of 6-inch pipe line beginning at a point of connection with the interstate pipe line of Utah Oil Refining Company (which point of connection is known as Wasatch Junction and is located approximately 336 feet north and approximately 246 feet west of the southeast corner of said Section 23) and extending easterly approximately 1243 feet to the pipe manifold serving the receiving tanks of Grantor at Grantor's Woods Cross refinery (which pipe manifold is located approximately 1002 feet east and approximately 305 feet north of the southwest corner of said Section 24); together with all pipes, valves, manifolds, fittings, equipment, rights of way, easements, permits, and all other property, real, personal or mixed, used in connection with said pipe line system; and together with the right, privilege, easement and right of way to lay, maintain, inspect, erect, operate and remove said pipe line system.

TO HAVE AND TO HOLD the above described property, together with all and singular the rights and appurtenances thereunto in anywise belonging, unto the said Phillips Pipe Line Company, its successors and assigns, forever.
