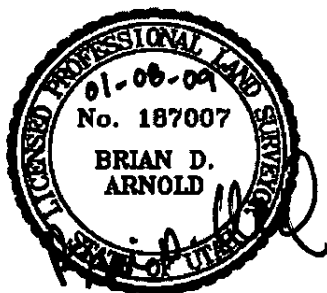

The recorded plat mistakenly included the following described parcel in Links Drive to be dedicated as Public Right-of-Way to West Valley City. Therefore this parcel is to be excluded from the boundaries of the recorded subdivision plat and is not to be shown as dedicated public right-of-way. The parcel of land to be hereby excluded is more particularly described as follows:

PARCEL DESCRIPTION

Beginning at a point on the quarter section line, said point being South 89° 49'45" East 725.14 feet along the quarter section line from the center of Section 19, Township 1 South, Range 1 West, Salt Lake Base and Meridian; running thence South 89° 49'45" East 1134.75 feet along the quarter section line; thence Southeasterly 125.52 feet along the arc of a 233.00 foot radius curve to the right (chord bears South 74° 23'46" East, 124.01 feet) through a central angle of 30° 51'58"; thence North 89° 49'45" West 119.54 feet to a point of curvature on the centerline of said Links Drive; thence along said centerline the following three courses (1) North 89° 49'45" West 536.58 feet (2) Northwesterly 299.69 feet along the arc of a 2719.00 foot radius curve to the right (chord bears North 86° 40'18" West, 299.54 feet) through a central angle of 06° 18'55" (3) Northwesterly 299.69 feet along the arc of a 2719.00 foot radius curve to the left (chord bears North 86° 40'18" West, 299.54 feet) through a central angle of 06° 18'55" to the point of beginning.
