**DECLARATION OF CONDOMINIUM
FOR
SAN TROPEZ AT THE SOUTH DISTRICT**

THIS DECLARATION OF CONDOMINIUM (as amended from time to time, this "Declaration") is made as of March ____, 2009, by San Tropez Holdings, LLC, a Utah limited liability company (together with its successors and assigns, "Declarant"), with the consent of Valley Green Holdings, LLC, a Utah limited liability company ("Valley Green"), an undivided interest owner, with Declarant, of the Land described herein.

RECITALS

A. Declarant, together with Valley Green, owns the land generally located to the North of 11800 South Street in the City of South Jordan between District Boulevard and District Drive, which land is located in the County of Salt Lake, State of Utah, and is more particularly described on Exhibit A.

B. Declarant, with the consent of Valley Green, desires to create a condominium project on such land pursuant to the Utah Condominium Ownership Act, Utah Code §§ 57-8-1 through 57-8-39, as the same may be amended from time to time. The condominium project will be known as "San Tropez At The South District."

C. Declarant, with the Consent of Valley Green, deems it necessary and desirable to subject such property, and all improvements now or hereafter constructed on such property, to the covenants, conditions, restrictions, reservations, easements, assessments, charges, and liens set forth in this Declaration.

DECLARATION

In consideration of the foregoing, Declarant, with the consent of Valley Green, hereby declares as follows:

**Article 1
DEFINITIONS**

As used in this Declaration, the following terms have the meanings given to them in this Article 1.

1.1 Act.

The Utah Condominium Ownership Act, Utah Code Unannotated §§ 57-8-1 through 57-8-36 (2007), as the same may be amended from time to time.

1.2 Area.

When reference is made to a Unit or Units, means the total number of square feet of the ground or floor surface thereof, rounded to the nearest whole number ending in zero, and computed and determined as follows on the basis of dimensions shown on the Plat. The measurements used in determining Area will run from the interior surfaces of the walls surrounding the Unit concerned and each separate level, story, or floor contained within or making up the Unit will be taken into account and, subject to the following provisions, will augment the Area thereof. So long as it substantially complies with the provisions of this Section 1.2 and is not arbitrary, Declarant's determination of the Area of a Unit, as set forth in this Declaration or in any amendment hereto will be conclusive.

1.3 Articles.

The Articles of Incorporation of the Association, as the same may be amended from time to time.

1.4 Assessment.

A General Assessment, a Special Assessment, or a Default Assessment levied and assessed pursuant to Article 7.

1.5 Assessment Lien.

The meaning given to that term in Section 7.8.

1.6 Association.

The association of Unit Owners known as the San Tropez At The South District Condominium Association, Inc., a Utah nonprofit corporation, and its successors and assigns.

1.7 Association Documents.

The Declaration, the Articles, the Bylaws, and the Rules and Regulations, as the same may be amended from time to time.

1.8 Building[s].

A structure containing or to contain one or more Units or Common Elements, as shown on the Plat.

1.9 Bylaws.

The bylaws of the Association, attached hereto and forming a part hereof as Exhibit B, as the same may be amended from time to time.

1.10 Common Elements.

The General Common Elements and the Limited Common Elements.

1.11 Common Expenses.

Means:

(a) any and all costs, expenses and liabilities incurred by or on behalf of the Association, including, without limitation, costs, expenses and liabilities for (i) managing, operating, insuring, improving, repairing, replacing, and maintaining the Common Elements; (ii) providing facilities, services, and other benefits to Owners; (iii) administering and enforcing the covenants, conditions, restrictions, reservations, and easements created hereby including, but not limited to, the Rules and Regulations; (iv) levying, collecting, and enforcing the Assessments, charges, and liens imposed pursuant hereto; (v) regulating and managing the Condominium Project; and (vi) operating the Association;

(b) costs, expenses, and liability agreed upon as Common Expenses by the Association or declared to be Common Expenses by this Declaration, the Act, or the Association;

(c) all sums lawfully assessed against the Unit Owners; and

(d) reserves for any such costs, expenses and liability.

1.12 Condominium Project.

The real estate condominium project created on the Land by this Declaration, consisting of the Units and the Common Elements, known as San Tropez At The South District.

1.13 Condominium Unit.

A Unit together with:

(a) the Interest in Common Elements appurtenant to that Unit;

(b) the right to the exclusive or nonexclusive use of the General Common Elements and Limited Common Elements appurtenant to that Unit, if any; and

(c) the membership in the Association appurtenant to that Unit.

1.14 Declarant.

San Tropez Holdings, LLC, a Utah limited liability company, and its successors and assigns.

1.15 Declarant Control Period.

The meaning given to that term in Section 6.3.

1.16 Declaration.

The Declaration of Condominium for San Tropez At The South District, as the same may be amended from time to time.

1.17 Default Assessment

The meaning given to that term in Section 7.6.

1.18 Director.

A duly elected or appointed member of the Management Committee.

1.19 First Mortgage.

Any Mortgage which is not subordinate to any other lien or encumbrance, except liens for taxes or other liens which are given priority by statute.

1.20 First Mortgagee.

A Mortgagee under a First Mortgage.

1.21 General Assessment.

The meaning given to that term in Section 7.4.

1.22 General Common Elements.

All of the areas of the Condominium Project, other than the Units and the Limited Common Elements. Without limiting the generality of the preceding sentence, the General Common Elements include, without limitation:

(a) the Land;

(i) all Improvements, including, without limitation, the foundations, columns, girders, beams, supports, perimeter and supporting walls, drainage facilities, yards, gardens, parking areas (except for driveways, porches, patio areas, private yards and other outdoor features designated as Limited Common Elements) and in general all apparatus and installations existing for common use, and all other parts of the Land and Buildings necessary or convenient to the existence, maintenance, and safety of the Condominium Project, or normally in use by two or more Units, except for those Improvements that are designated by the Act, by this Declaration or by the Plat as Units or Limited Common Elements; and

(ii) any parcels of real property and improvements and fixtures located thereon (A) that are owned by a Person other than the Association, but in which the Association has rights of use or possession pursuant to this Declaration or a lease, license, easement, or other agreement, and (B) that are used or possessed by the Association for the benefit of all Owners.

1.23 Guest.

Any family member, employee, agent, independent contractor, lessee, customer, or invitee of an Owner.

1.24 Improvement.

The Buildings, together with any other building, structure, or other improvement (including, without limitation, all fixtures and improvements contained therein) located on the Land and within which one or more Units or Common Elements are or will be located.

1.25 Interest in Common Elements.

The undivided interest in the Common Elements appurtenant to each Unit, determined in accordance with the terms and conditions of Section 3.3.

1.26 Land.

The real property which Article 2 of this Declaration submits to the terms of the Act.

1.27 Limited Common Elements.

The Limited Common Elements designated by this Declaration or the Plat for the exclusive use of one or more Units, but fewer than all of the Units. Without limiting the generality of the foregoing, "Limited Common Elements" includes, without limitation,

(a) any windows, doors, doorsteps, porches, balconies, patios, private yard and other apparatus intended to serve a single Unit but located outside the boundaries of such Unit;

(b) all installations for and all equipment connected with furnishing the Condominium Project with utility service, including, but not limited to, utility systems, mechanical systems, and exhaust and ventilation systems;

(c) any parcels of real property and Improvements and fixtures located thereon (i) that are owned by a Person other than the Association, but in which the Association has rights of use or possession pursuant to this Declaration or a lease, license, easement, or other agreement, and (ii) that are used or possessed by the Association for the benefit of Owners of fewer than all of the Units; and

(d) one balcony or patio surface (not including or extending into decking or other materials constituting the balcony or patio, excluding the exterior surface of all walls of a Building which may surround part of the balcony or patio, excluding the railings which may, in part, contain the balcony or patio, and excluding the roof or decking (including the surface thereof) above the balcony or deck, all of which exclusions will remain General Common Elements and not Limited Common Elements), as assigned to each Unit as more particularly shown on the Plat.

If any chute, flue, duct, wire, conduit, bearing wall, bearing column, or other structural component, any portion of a mechanical system, or any fixture lies partially within and partially outside of the designated boundaries of a Unit, any portion thereof serving only that Unit is a Limited Common Element allocated solely to that Unit, and any portion thereof serving more than one Unit or any portion of the Common Elements is a part of the General Common

Elements. Nonstructural walls located wholly within a Unit are a part of the Units in which they are located.

1.28 Management Committee

The Association's board of directors which will also be and have all of the rights, duties, and authority of the management committee described by the Act, except as otherwise expressly provided herein.

1.29 Majority

Regardless of whether capitalized, means the Owners of more than fifty percent of the aggregate interest in Common Elements.

1.30 Mortgage

Any mortgage, deed of trust, or other document pledging any Condominium Unit or interest therein as security for payment of a debt or obligation.

1.31 Mortgagee.

Any Person named as a mortgagee or beneficiary in any Mortgage and any successor to the interest of any such Person under a Mortgage.

1.32 Officer.

A duly elected or appointed officer of the Association.

1.33 Owner.

The Person who is the record holder of legal title to the fee simple interest in any Condominium Unit as reflected in the Salt Lake County Records. If there is more than one record holder of legal title to a Condominium Unit, each record holder will be an Owner. The term "Owner" includes Declarant to the extent that Declarant is the record holder of legal title to the fee simple interest in a Condominium Unit. Notwithstanding any applicable theory relating to a mortgage, deed of trust, or like instrument, the term "Owner" will not mean or include a mortgagee or a beneficiary or trustee under a deed of trust unless and until such Person has acquired title pursuant to foreclosure or any arrangement or proceeding in lieu thereof.

1.34 Person.

Any natural person, corporation, partnership, limited liability company, association, trustee, governmental or quasi-governmental entity, or any other entity capable of owning real property under the laws of the State of Utah.

1.35 Plat.

The Condominium Plat filed herewith, entitled "San Tropez At The South District, A Utah Condominium Project" executed and acknowledged by Declarant, consisting of 14 sheets,

and prepared by Gregory A. Cates, a duly registered Utah Land Surveyor holding License m 161226, as such Condominium Plat may be amended or supplemented in accordance with law and the provisions hereof from time to time.

1.36 Purchaser.

A Person, other than Declarant or a Successor Declarant, who acquires legal title to the fee simple interest in any Condominium Unit or portion thereof.

1.37 Record, Recording, Recorded, and Recorder.

Each have the meaning stated in Utah Code Annotated § 57-3-101 through § 57-3-102, as the same may be amended from time to time.

1.38 Rules and Regulations.

Any instrument adopted from time to time by the Association for the regulation and management of the Condominium, as the same may be amended from time to time. Such rules and regulations may include, without limitation: (a) a requirement that draperies, shades, or other interior window coverings, including the interior surfaces of any window or door glass used in Units will present a uniform appearance of type and color from the exterior of any Building or all Buildings and that the Association will have the right to inspect and reinspect and approve all proposed draperies, shades, or other interior window coverings to insure compliance with such rules before installation thereof in a Unit, and (b) that Limited Common Elements conform to standardized regulations regarding appearance, maintenance, and modifications thereof.

1.39 Salt Lake County Records.

The Official Records for Salt Lake County, Utah.

1.40 Share of Common Expenses.

The share of Common Expenses allocated to each Unit in accordance with the terms and conditions of Section 7.2.

1.41 Special Assessment.

The meaning given to that term in Section 7.5.

1.42 Special Declarant Rights.

All rights that Declarant reserves for itself in this Declaration.

1.43 Successor Declarant.

Any Person who succeeds to any Special Declarant Right.

1.44 Unit

A physical portion of the Condominium Project that:

- (a) consists of one or more rooms or spaces located in one or more floors or parts of floors located in a Building;
- (b) is designated for separate ownership and independent use; and
- (c) is designated as a Unit in Exhibit C of this Declaration and on the Plat.

The walls, floors, or ceilings are designated as boundaries of a Unit, and all paneling, tiles, wallpaper, painting, finished flooring, and any other materials constituting any portion of the finished surfaces thereof are part of the Unit, and all other portions of the walls, floors, and ceilings are part of the Common Elements.

1.45 Unit Number.

The number, letter, or combination thereof which designates a Unit on the attached Exhibit C and on the Plat.

Article 2 SUBMISSION

2.1 **Submission.** There is hereby submitted to the provisions of the Act, as the Land associated with the San Tropez At The South District, the following-described parcel of real property situated in Salt Lake County, State of Utah:

See Exhibit A attached hereto and incorporated herein by this reference.

TOGETHER WITH: (a) all Buildings, if any, improvements, and structures situated on or comprising a part of the above-described parcel of real property; (b) all easements, rights-of-way, and other appurtenances and rights incident to, appurtenant to, or accompanying said parcel; and (c) all articles of personal property intended for use in connection with said parcel.

ALL OF THE FOREGOING IS SUBJECT TO: all liens for current and future taxes, assessments, and charges imposed or levied by governmental or quasi-governmental authorities; all patent reservations and exclusions; any mineral reservations of record and rights incident thereto; all instruments of record which affect the above-described Land or any portion thereof, including, without limitation, any mortgage or deed of trust; all visible easements and rights-of-way; all easements and rights-of-way of record; any easements, rights-of-way, encroachments, or discrepancies shown on or revealed by the Plat or otherwise existing; an easement for each and every pipe, line, cable, wire, utility line, or similar facility which traverses or partially occupies the above-described Land at such times as construction of all improvements is complete; and all easements necessary for ingress to, egress from, maintenance of, and replacement of all such pipes, lines, cables, wires, utility lines, and similar facilities.

RESERVING UNTO DECLARANT, however, such easements and rights of ingress and egress over, across, through, and under the above-described Land and any improvements now or hereafter constructed thereon as may be reasonably necessary for Declarant or for any assignee or successor of Declarant (in a manner which is reasonable and not inconsistent with the provisions of this Declaration): (i) To construct and complete the Buildings and all of the other improvements described in this Declaration or in the Plat recorded concurrently herewith, and to do all things reasonably necessary or proper in connection therewith; and (ii) To improve portions of the Land with such other or additional improvements, facilities, or landscaping designed for the use and enjoyment of all the Owners as Declarant or as such assignee or successor may reasonably determine to be appropriate. If, pursuant to the foregoing reservations, the above-described Land or any improvement thereon is traversed or partially occupied by a permanent improvement or utility line, a perpetual easement for such improvement or utility line will exist. With the exception of such perpetual easements, the reservations hereby effected will, unless sooner terminated in accordance with their terms, expire five years after the date on which this Declaration is filed for record in the Salt Lake County Records.

2.2 **Covenants Running with the Land.**All covenants, conditions, restrictions, reservations, easements, charges, liens and other provisions of this Declaration are covenants running with the land, or equitable servitudes, as the case may be. The obligations, burdens and benefits created by this Declaration will bind and inure to the benefit of Declarant, the Owners (as such term is defined below), the Association (as that term is defined below), all other parties having any, right, title or interest in the Land or any portion thereof and their respective successors, assigns, heirs, devisees, executors, administrators and personal representatives. Each Owner will comply strictly with the covenants, conditions and restrictions as set forth in this Declaration or in the deed to his Unit, and with the Bylaws and/or house rules and with the administrative rules and regulations drafted pursuant thereto, as either of the same may be lawfully amended from time to time, and failure to comply will be ground for an action to recover sums due for damages, injunctive relief or both, maintainable by the Management Committee on behalf of the Owners, or in a proper case, by an aggrieved Owner.

2.3 **Statement of Intention.**The condominium project to be created on the Land is hereby created pursuant to and will be governed by the provisions of the Act.

Article 3 BUILDINGS, UNITS, AND COMMON ELEMENTS

3.1 **The Buildings.**The Improvements included in the Condominium Project are now or will be located on the Land. The significant Improvements contained in the Condominium Project include eleven Buildings containing a total of 250 Units and 96 enclosed garage spaces with driveways, a clubhouse, exterior parking spaces as shown on the Plat, asphalt or concrete driveways, and the Common Elements. The location and configuration of the Improvements referred to in the foregoing sentence are depicted on the Plat. The Condominium Project also contains other improvements of a less significant nature, such as outdoor lighting, fencing, area landscaping, and concrete sidewalks and walkways. The Plat shows the number of stories and the number of Units which are contained in the Buildings included in the Condominium Project.

(b) The principal materials used or to be used in the construction of the Buildings are as follows: all load bearing and non-load bearing walls are wood frame or concrete; the above-grade floors are of wooden joists covered with plywood and concrete; the roof is of wood covered with asphalt/fiberglass shingles; interior walls are surfaced with sheetrock or gypsum board; and exterior walls are surfaced with ledgestone, stucco and siding.

3.2 **Units.**Declarant hereby creates 250 Units within the Condominium Project. The Plat shows the Unit Number of each Unit, its location, dimensions from which its Area may be determined, and the General Common Elements and Limited Common Elements to which it has access. Each Unit will be capable of being separately owned, encumbered and conveyed. Each Owner of a Unit will be entitled to the exclusive ownership and possession of such Owner's Unit, subject to the terms and conditions of this Declaration.

(b) No Owner may alter its Unit, subdivide its Unit, or relocate the boundaries between a Unit and an adjacent Unit, except as expressly provided by this Declaration and the Act.

(c) Except as expressly provided to the contrary in this Declaration, the Interest in Common Elements and the right to use Limited Common Elements appurtenant to the Unit may not be partitioned or separated from the Unit or any part thereof; provided that this subsection will not prejudice or otherwise affect the rights set forth in Article 13 and Article 14 of this Declaration in the event of casualty or condemnation.

(d) Notwithstanding anything to the contrary contained in Sections 3.2(b) and 3.2(c) or elsewhere in this Declaration:

(i) nothing will prevent or limit Declarant's exercise or enjoyment of any Special Declarant Right; and

(ii) an Owner may grant its rights to use any General Common Element or any Limited Common Element appurtenant to the Owner's Unit to the Owner's Guests.

3.3 Interests in Common Elements. The Interests in Common Elements will be allocated among the Units as set forth in this Section 3.3. Each Unit shall have an equal Interest in Common Elements. The Interests in Common Elements which are appurtenant to the Units and which are set forth on Exhibit C have been computed in the aforesaid manner.

(b) The Interest in Common Elements appurtenant to each of the Units of the Condominium Project are set forth on Exhibit C attached hereto and made a part hereof.

(c) The Interest in Common Elements will have a permanent character and, except for corrections in the Condominium Plat and/or this Declaration, will not be altered without the express consent of all Owners expressed in an amendment to this Declaration adopted as provided in Section 17.3.

(d) Except as expressly provided to the contrary elsewhere in this Declaration, an Interest in Common Elements may not be partitioned from the Unit to which it is appurtenant, and any purported conveyance, encumbrance or transfer of an Interest in Common Elements made without the Unit to which the Interest in Common Elements is appurtenant will be void. The immediately foregoing sentence will not prejudice or otherwise affect the rights set forth in Article 13 and Article 14 of this Declaration in the event of casualty or condemnation. There will not be any restriction upon an Owner's right of ingress to and egress from such Owner's Unit.

3.4 **Limited Common Elements.** Except as expressly provided to the contrary in this Declaration, the allocation of the Limited Common Elements to the Units as shown on the Plat may not be altered without the consent of all Owners whose Units would be affected by such reallocation.

3.5 **Separate Taxation of Condominium Units.** Pursuant to the Act, each Condominium Unit constitutes a separate parcel of real estate and will be separately assessed and taxed.

3.6 **Description of Condominium Units.** Any deed, lease, mortgage, deed of trust, or other instrument conveying, encumbering, or otherwise affecting a Condominium Unit will describe the interest or estate substantially as follows:

[Building ____], [Unit ____], contained within the San Tropez At The South District as the same is identified in the Condominium Plat recorded in Salt Lake County, Utah, on _____, 2009, as Entry No. _____ (as said Condominium Plat will have heretofore been amended or supplemented) and in the Declaration of Condominium for San Tropez At The South District, recorded in Salt Lake County, Utah on _____, 2009, as Entry No. _____, in Book No. _____ at Page _____ (as said Declaration may have heretofore been amended or supplemented). TOGETHER WITH the undivided ownership interest in said Condominium Project's Common Elements that is appurtenant to said Unit as more particularly described in said Declaration.

Whether or not the description employed in any such instrument is in the above-specified form, however, all provisions of this Declaration will be binding upon and will inure to the benefit of any party who acquires any interest in a Condominium Unit. Neither the Interest in Common Elements, nor the right of exclusive use of a Limited Common Elements, will be separated from the Unit to which it appertains; and, even though not specifically mentioned in the instrument of transfer, such Interest in the General Common Elements and such right of exclusive use will automatically accompany the transfer of the Unit to which they relate.

3.7 **Interpretation.**In interpreting this Declaration, the Plat or any deed or other instrument affecting the Building or a Unit, the boundaries of the Building or Unit constructed or reconstructed in substantial accordance with the Plat will be conclusively presumed to be the actual boundaries rather than the description expressed in the Plat, regardless of settling or lateral movement of the Building and regardless of minor variance between boundaries shown on the Plat and those of the Building or Unit.

Article 4 THE ASSOCIATION

4.1 **Formation of the Association.**On or before the date on which Declarant conveys the first Unit to a Purchaser, Declarant will form the Association.

4.2 **Purposes and Powers.**The Association's purposes are:

(i) to manage, operate, insure, construct, improve, repair, replace, alter, and maintain the Common Elements;

(ii) to provide certain facilities, services and other benefits to the Owners;

(iii) to administer and enforce the covenants, conditions, restrictions, reservations, and easements created hereby;

(iv) to levy, collect, and enforce the Assessments, charges, and liens imposed pursuant hereto;

(v) to enter into agreements with other Persons, including, without limitation, easements, licenses, leases, and other agreements with one or more Persons for facilities and services that serve the Association;

(vi) to take any action that it deems necessary or appropriate to protect the interests and general welfare of Owners;

(vii) to regulate and manage the Condominium Project; and

(viii) to execute and record, on behalf of all Owners, any amendment to this Declaration or the Plat which has been approved by the vote or consent necessary to authorize such amendment.

(b) Unless expressly prohibited by law or any of the Association Documents, the Association may:

(i) take any and all actions that it deems necessary or advisable to fulfill its purposes;

(ii) exercise any powers conferred on it by the Act or any Association Document; and

(iii) exercise all powers that may be exercised in Utah by nonprofit corporations.

(c) Without in any way limiting the generality of Section 4.2(b), the Association may, but is not obligated to:

(i) to the extent not provided by a public, quasi-public or private utility provider, provide certain facilities and services to the Owners, such as (A) recreational facilities and services, (B) water, sewer, natural gas, electric, cable television, and other utility services, (C) parking facilities, and (D) trash collection facilities and services for residential purposes only;

(ii) acquire, sell, lease and grant easements over, under, across and through Common Elements which are reasonably necessary to the ongoing development and operation of the Condominium Project;

(iii) borrow monies and grant security interests in the Common Elements and in the assets of the Association as collateral therefor;

(iv) make capital improvements, repairs, and replacements to Common Elements; and

(v) hire and terminate managers and other employees, agents, and independent contractors.

4.3 Association Documents. This Declaration and the Plat create the Condominium Project and set forth certain covenants, conditions, restrictions, reservations, easements, assessments, charges, and liens applicable to the Land. The Articles create the Association. The Bylaws provide for the regulation and management of the Association, and the Rules and Regulations provide for the regulation and management of the Condominium Project.

(b) Except as expressly provided in the Act, if there is any conflict or inconsistency between the terms and conditions of this Declaration and the terms and conditions of the Articles, the Bylaws, or the Rules and Regulations, the terms and conditions of this Declaration will control. If there is any conflict or inconsistency between the terms and conditions of the Articles and the terms and conditions of the Bylaws or the Rules and Regulations, the terms and conditions of the Articles will control. If there is any conflict or inconsistency between the terms and conditions of the Bylaws and the terms and conditions of the Rules and Regulations, the terms and conditions of the Bylaws will control.

4.4 **Books and Records.** The Management Committee, or manager, if any, will keep detailed, accurate records in chronological order, of receipts and expenditures affecting the Common Elements, specifying and itemizing the Common Expenses and any other expenses incurred. Upon request, the Association will allow Owners and Mortgagees and their respective agents to inspect current copies of the Association Documents and the books, records, budgets and financial statements of the Association during normal business hours and under other reasonable circumstances. The Association may charge a reasonable fee for copying such materials.

Article 5 VOTING

5.1 **Voting.** At any meeting of the Association, the Interest in Common Elements appurtenant to a Unit may be voted in connection with issues presented to the Owners for vote.

(b) The votes allocated to the Units of the Condominium Project are equal to the Interests in Common Elements set forth on Exhibit C attached hereto and made a part hereof.

(c) If any Units are added to or withdrawn from the Condominium Project the total number of votes allocated to all Memberships and the allocation thereof after such addition, withdrawal, increase or decrease will be adjusted so that such votes at all times remain equal to the Interest in Common Elements appurtenant to such Unit.

(d) The Owner of each Unit will be entitled to the number of votes allocated to it in accordance with Sections 5.1(a), (b), and (c), regardless of the number of Owners of the Unit. If the Owners of a Unit cannot agree among themselves as to how to cast their votes on a particular matter, they will lose their right to vote on such matter. If any Owner casts a vote representing a particular Unit, it will thereafter be presumed for all purposes that the Owner was acting with the authority and consent of all other Owners with whom such Owner shares the Unit, unless objection thereto is made by an Owner of that Unit to the Person presiding over the meeting at the time the vote is cast. If more than the number of allocated votes are cast for any particular Unit, none of such votes will be counted and all of such votes will be deemed null and void other than to determine whether a quorum exists.

(e) In any case in which the Act or this Declaration requires the vote of a stated percentage of the Owners or approval of an act or transaction, such requirement will be fully satisfied by obtaining, with or without a meeting, consents in writing to such transaction from Owners who collectively hold at least the stated percentage of required votes. Such written consents will be subject to the following conditions:

(i) All necessary consents must be obtained prior to the expiration of ninety days after the first consent is given by any Owner.

(ii) Any change in ownership of a Condominium Unit which occurs after consent has been obtained by the Owner having an interest therein will not be considered or taken into account for any purpose.

(iii) Unless consent of all Owners having an interest in the same Condominium Unit is secured, the consent of none of such Owners will be effective.

Article 6
MANAGEMENT COMMITTEE

6.1 Number and Election of Directors. The Management Committee will consist of three Directors. The initial Directors will hold office until the election or appointment of their successors at the first annual meeting. Thereafter, subject to the terms and conditions of Sections 6.3, 6.4, and 6.5, each Director will hold office for a term of one year and the Owners will elect the Directors at the annual meetings.

6.2 Powers of the Management Committee. Except as provided in this Declaration, the Articles and the Bylaws, the Management Committee may act on behalf of the Association in all instances.

(b) The Management Committee may not act on behalf of the Association to:

- (i) amend this Declaration;
- (ii) terminate the Association, this Declaration or the Condominium;
- (iii) elect Directors to the Management Committee; or
- (iv) determine the qualifications, powers and duties, or terms of office, of Directors.

6.3 Declarant Control Period. Subject to the terms and conditions of Sections 6.3(b) and (c), but notwithstanding anything else to the contrary contained in this Declaration or in any other Association Document, Declarant will have the exclusive right to appoint and remove all Directors and Officers during the Declarant Control Period. The phrase "Declarant Control Period" means the period commencing on the date on which this Declaration is Recorded, and ending on the first to occur of the following:

- (i) three years from the date that the Declaration is Recorded; or
- (ii) the date upon which Units representing seventy-five percent of the total Interests in the General Common Elements have been conveyed to Purchasers, or after all Additional Land has been added to the Condominium Project and all Convertible Land has been converted, whichever last occurs.

(b) Declarant may voluntarily surrender its right to appoint and remove Officers and Directors prior to the expiration of the Declarant Control Period, but, in that event, Declarant may require, for the remainder of the Declarant Control Period, that specific actions of the Association or the Management Committee, as described in a recorded instrument executed by Declarant, be approved by the Declarant before they become effective.

(c) During the thirty day period immediately preceding the date on which the Declarant Control Period expires, the Owners will elect a Management Committee of three Directors as set forth in Section 6.1, at least a majority of whom must be Owners other than Declarant or designated representatives of Owners other than Declarant. Such Directors will take office upon election.

(d) No management contract, lease of recreational areas or facilities, or any other contract or lease designed to benefit the Declarant which was executed by or on behalf of the Association or the Unit Owners as a group will be binding after the expiration of the Declarant Control Period unless renewed or ratified by the consent of a Majority of the votes in the Association.

6.4 Removal of Directors. Directors appointed by Declarant may be removed, with or without cause, solely by Declarant.

(b) Each Director, other than a Director appointed by Declarant, may be removed, with or without cause, by a sixty-seven percent or greater vote of all Owners of the Units.

6.5 Replacement of Directors. Vacancies on the Management Committee created by the removal, resignation or death of a Director appointed by Declarant will be filled by a Director appointed by Declarant.

(b) A vacancy on the Management Committee created by the removal, resignation or death of a Director appointed or elected by the Owners will be filled by a Director elected by the Owners.

(c) Any Director elected or appointed pursuant to this Section 6.5 will hold office for the remainder of the unexpired term of the Director that Director replaced.

6.6 Management Committee Liability. No Director will be liable to the Owners for any mistake in judgment, for negligence, or on other grounds, except for such Director's own individual and willful misconduct or bad faith. The Owners and Association will indemnify and hold harmless each Director from and against all liability to third parties arising out of any contract made by the Management Committee on behalf of the Association or Owners, unless such contract was made in bad faith or contrary to the provisions of the Act or this Declaration. The liability of an Owner arising out of the foregoing indemnification will be limited to the total liability concerned multiplied by such Owner's Interest in Common Elements.

Article 7

ASSESSMENTS, COMMON EXPENSES, BUDGETS, AND LIENS

7.1 Obligations for Assessments. Each Owner, by accepting a deed to a Unit (regardless of whether it will be expressly stated in such deed), will be deemed to have covenanted and agreed to pay to the Association all:

(i) General Assessments;

- (ii) Special Assessments;
- (iii) Default Assessments; and
- (iv) other charges,

that the Association is required or permitted to levy or impose on such Owner or such Owner's Unit pursuant to this Declaration or any other Association Document.

(b) Notwithstanding the definition of the term "Owner":

(i) a Person who acquires a Unit in a foreclosure sale will be personally liable for all Assessments and other charges that the Association is required or permitted to levy or impose on that Unit or on the Owner of that Unit on or after the date of the foreclosure sale; and

(ii) a Person who acquires a Unit by deed-in-lieu of foreclosure will be personally liable for all Assessments and other charges that the Association is required or permitted to levy or impose on that Unit or on the Owner of that Unit on or after the date on which the Owner of the Unit executes the deed-in-lieu of foreclosure.

(c) No Owner will be exempt from liability for any such Assessment or other charges by waiving the use or enjoyment of any Common Element or by abandoning a Unit against which such Assessments or other charges are made.

(d) Each Owner will be personally liable for all Assessments and other charges levied on such Owner or such Owner's Unit during the period of such Owner's ownership of the Unit. If there is more than one Owner of a Unit, each Owner will be jointly and severally liable with the other Owners of the Unit for all Assessments and other charges levied on the Unit or any Owner of the Unit. In a voluntary conveyance, the grantee of a Unit will be jointly and severally liable with the grantor for all unpaid Assessments against the grantor without prejudice to the grantee's rights to recover from the grantor the amount of the Assessment paid by the grantee.

(e) Each Assessment or other charge, together with interest and penalties thereon and all costs and expenses incurred by the Association to collect such Assessment or other amount, including all fees and disbursements of attorneys, accountants, appraisers, receivers and other professionals engaged by the Association in connection therewith, may be recovered by a suit for a money judgment by the Association without foreclosing or waiving any Assessment Lien securing the same.

7.2 Shares of Common Expenses. Except as otherwise set forth in this Declaration, the Association's Common Expenses will be allocated among the Units in accordance with the Interest in Common Elements appurtenant to such Units (the "Shares of Common Expenses").

7.3 Budgets. Prior to the first levy of a General Assessment, and thereafter on or before October 1 of each calendar year, the Management Committee will adopt a proposed annual budget for the Association for the following calendar year that sets forth:

(i) the Management Committee's estimates of Common Expenses for the next calendar year, taking into account any default or surplus realized for the current calendar year and any amounts as may be necessary to fund the reserve provided for in Section 7.11 of this Declaration;

(ii) the amount of funds for such Common Expenses that the Management Committee proposes to raise through General Assessments; and

(iii) the amount of funds for such Common Expenses that the Management Committee proposes to raise through Special Assessments.

(b) Within thirty days after adopting a proposed annual budget, the Management Committee will deliver a summary of the proposed annual budget to the Owners and set a date for a meeting of the Owners to consider ratification of the proposed annual budget. The date of such meeting will not be less than fourteen days nor more than sixty days after the delivery of the summary of the proposed annual budget to the Owners. Unless at that meeting a Majority of the votes, whether or not a quorum is present, rejects the proposed annual budget, the proposed annual budget will be deemed ratified. If the proposed annual budget is rejected, the annual budget last ratified by the Owners will be deemed renewed for the next calendar year and will remain in full force and effect until such time as the Owners ratify a subsequent annual budget proposed by the Management Committee.

(c) If the Management Committee deems it necessary or advisable to amend an annual budget that has been ratified by the Owners under Section 7.3(b), the Management Committee may adopt a proposed amendment to the annual budget, deliver a summary of the proposed amendment to all Owners and set a date for a meeting of the Owners to consider ratification of the proposed amendment. The date of such meeting will not be less than fourteen days nor more than sixty days after the delivery of the summary of the proposed amendment. Unless at that meeting a Majority of the votes, whether or not a quorum is present, rejects the proposed amendment, the proposed amendment will be deemed ratified.

7.4 General Assessments. After the Management Committee has adopted an annual budget pursuant to Section 7.3(b), the Association will levy an assessment for Common Expenses (a "General Assessment") on each Unit. The amount of the General Assessment levied against a Unit will equal the product obtained by multiplying:

(i) the amount set forth in the annual budget adopted by the Management Committee as the amount of Common Expenses to be raised by General Assessments, by

(ii) that Unit's Interest in Common Elements.

(b) The Owners will pay the General Assessments levied against their respective Units in such periodic installments as may be required by the Association.

(c) If the Management Committee adopts an amendment to the General Assessment portion of an annual budget pursuant to Section 7.3(c), the amount of the General Assessment levied against each Unit will be adjusted accordingly, as will the amount of each Owner's periodic installments.

(d) If the Management Committee fails to adopt an annual budget for any calendar year prior to January 1 of that calendar year, the Owners will continue to pay periodic installments of the General Assessment to the Association at the rate payable during the prior calendar year until such time as the Management Committee adopts a new annual budget for the then current calendar year. Once the Management Committee adopts a new annual budget, the Association will levy against each Unit the General Assessment for the then current calendar year and each Owner's periodic installments will be adjusted as necessary to pay the new General Assessment in equal periodic installments over the remainder of such calendar year, giving the Owners credit, in such manner as the Management Committee deems necessary or appropriate, for any installments that the Owners have previously paid to the Association during such calendar year.

(e) The failure of the Association to levy a General Assessment for any calendar year will not be deemed a waiver, modification or release of an Owner's liability for the Share of Common Expenses allocated to such Owner's Unit.

7.5 Special Assessments. The Assessments that the Association may levy pursuant to this Section 7.5 are referred to in this Declaration as "Special Assessments."

(b) Notwithstanding anything to the contrary contained in Section 7.4, if the Association determined that an Assessment is required to immediately fund any Common Expense attributable to the Common Elements, the Association may levy an Assessment for such Common Expense against the Units in proportion to the Interests of General Common Elements

(c) Each Special Assessment levied against any Unit will be shown on an annual budget, or an amendment to an annual budget, adopted by the Management Committee pursuant to Section 7.3 and will be paid as and when required by the Association.

7.6 Default Assessments. Notwithstanding anything to the contrary contained herein, if any Common Expense is caused by:

(i) the negligence or misconduct of an Owner or an Owner's Guest; or

(ii) a violation of any covenant or condition of an Association Document by an Owner or an Owner's Guest, the Association may levy an Assessment for such Common Expense against such Owner's Unit. Any such Assessment levied by the Association and each fine, penalty, fee or other charge imposed upon an Owner for the Owner's violation of

any covenant or condition of any Association Document are each referred to herein as a "Default Assessment."

(b) Default Assessments need not be shown on an annual budget, or on an amendment to an annual budget, adopted by the Management Committee pursuant to Section 7.3.

(c) With respect to any Default Assessment, or portion thereof, levied other than as a late charge, the Owner of the Unit against which the Association seeks to levy the Default Assessment will be provided notice and an opportunity to be heard. Owners of Units against which Default Assessments have been levied will pay such Default Assessments as and when required by the Association.

7.7 Assignment of Assessments. The Association will have the unrestricted right to assign its right to receive Assessments and other future income, either as security for obligations of the Association or otherwise, on the condition that any such assignment is approved by a majority of the votes allocated to Units represented at a meeting at which a quorum is present.

7.8 Assessment Lien. The Association will have a lien on each Unit for any Assessment levied against that Unit and for any fines, late charges, penalties, interest and attorneys' fees, disbursements and costs of collection imposed against the Owner of such Unit under any Association Document (the "Assessment Lien"). The Assessment Lien will secure all of the foregoing obligations of an Owner from the time such obligations become due. If an Assessment is payable in installments, the Assessment Lien will secure each installment from the time it becomes due, including the due date set by any valid Association acceleration of installment obligations.

(b) An Assessment Lien will constitute a lien upon the Owner's Unit, and, upon the Recording of a notice of lien by the Management Committee or manager, if any, it is a lien prior to all other liens and encumbrances on a Unit, recorded and unrecorded except:

(i) encumbrances on the interest of an Owner recorded prior to the date such notice is recorded which by law would be a lien prior to subsequently recorded encumbrances; and

(ii) liens for real estate taxes and special assessment liens on the Unit in favor of any governmental assessing unit or special improvement district; and

(c) An Assessment Lien is prior to a First Mortgage recorded before the date on which the Assessment sought to be enforced became delinquent to the extent permitted by the Act.

(d) An Assessment Lien is extinguished unless proceedings to enforce the Assessment Lien are instituted within six years after the full amount of the Assessment secured thereby becomes due. Suit to recover a money judgment for unpaid Assessments is maintainable without foreclosing or waiving the lien securing it.

(e) This Section 7.8 does not prohibit actions or suits to recover sums secured by an Assessment Lien or the Association from taking a deed in lieu of foreclosure.

(f) In any action by the Association to collect Assessments or to foreclose an Assessment Lien for unpaid Assessments, the court may appoint a receiver of the Owner to collect all sums alleged to be owed by the Owner prior to or during the pendency of the action, including, but not limited to, all costs and expenses of such proceedings, reasonable attorneys' fees, and a reasonable rental for the Unit. A court may order the receiver to pay any sums held by the receiver to the Association during the pendency of the action to the extent of the Association's Assessments.

(g) An Assessment Lien may be foreclosed in like manner as a deed of trust or mortgage on real estate or in any other manner permitted by law. Periodic Assessments will be payable during the period of foreclosure of an Assessment Lien.

7.9 Waiver of Homestead Exemptions. To the fullest extent permitted by law, by acceptance of the deed or other instrument of conveyance of a Unit, an Owner irrevocably waives the homestead exemption provided by the Utah Exemptions Act, Utah Code § 78-23-1 through § 78-23-15 as amended from time to time, as the same may apply to the Assessment Lien.

7.10 Estoppel Certificates; Notices to Mortgagees. The Association will furnish to an Owner or such Owner's designee or to a Mortgagee or its designee upon written request, delivered personally or by certified mail, first-class postage prepaid, return receipt requested, to the Association's registered agent, and payment of a reasonable fee not to exceed the amount provided for in the Act, a statement setting forth the amount of unpaid Assessments currently levied against such Owner's Unit. The statement will be furnished within ten calendar days after receipt of the request and is binding on the Association, the Management Committee and every Owner in favor of all Persons who rely upon such statement in good faith. If no statement is furnished to the Owner, the Mortgagee or their designee, delivered personally or by certified mail, first-class postage prepaid, return receipt requested, to the inquiring party, then the Association will have no right to assert the priority of its Assessment Lien upon the Unit for unpaid Assessments which were due as of the date of the request.

(b) If a First Mortgagee delivers to the Association a written request for notice of unpaid Assessments levied against a Unit subject to a First Mortgage held by that First Mortgagee, the Association will report to the First Mortgagee any unpaid Assessments levied against such Unit that remain unpaid for more than sixty days after the same will have become due. The First Mortgagee may pay any such unpaid Assessment, together with any and all costs and expenses incurred with respect to the Assessment Lien securing such unpaid Assessment, and upon such payment, such First Mortgagee will have a lien on the Unit for the amounts paid with the same priority as a lien of the First Mortgage held by such First Mortgagee.

7.11 Reserve Fund. The Association will have the right to maintain a reserve fund for Common Expenses. The reserve fund will include such amounts as the Management Committee may deem proper for general working capital, for a general operating reserve, and for a reserve fund for replacements and major maintenance or capital replacement, and will be funded as

follows. At the closing of the sale of a Unit by Declarant to a Purchaser, the Purchaser will pay to the Association an amount equal to the Association's estimate of three months of Common Expenses for the fiscal year in which the sale of the Unit occurs. Thereafter, the Association may increase the reserve fund or replace funds withdrawn from the reserve fund with funds collected through Assessments.

(b) Payments by Purchasers to the Association at closings under Section 7.11(a) will not be credited against, or relieve Purchasers from, their obligation to pay other Assessments levied against Units by the Association.

(c) Upon the sale of a Unit from one Owner to another, the Association will not be obligated to return to the transferor any funds held in reserve, but the transferor will be entitled to an appropriate credit from its transferee.

Article 8 UTILITY AND OTHER SERVICES

8.1 Water, Sewer, Natural Gas, Electric, and Trash Removal Services. The Association will be responsible for obtaining water, sewer, trash, natural gas and electric service for all General Common Elements. All water, natural gas and electric services furnished to the Condominium Project will be separately metered and billed to an individual Unit and the Limited Common Elements appurtenant thereto by the utility company or other party furnishing such services will be paid for by the Owner of the Unit to which such utility is metered. All other water, sewer, natural gas, electric and trash removal services will be a part of the Common Expenses and the expense therefore will be paid by the Association to the provider thereof, subject to allocation by the Association among the Units and the Association's ability to charge the applicable allocation of the expense to the Owners in accordance with their respective Shares of Common Expenses.

(b) Each Owner will ensure that its Unit is sufficiently heated to prevent the freezing of water and sewer lines serving the Condominium Project.

8.2 Cable/Satellite Television. The Association may, but shall not be obligated, to obtain cable or satellite television services for the Units. The Owner of a Unit may obtain cable or satellite television services of such Owner's Unit; provided, however, that no satellite dish, antenna or other similar equipment may be attached to any Building without the prior written consent of the Association.

(b) All cable or satellite television services furnished to the Condominium Project which are separately metered and billed to an individual Unit by the cable company or other party furnishing such services will be paid for by the Owner of the Unit to which such services are metered. All other cable or satellite television services will be a part of the Common Expenses and will be allocated by the Association among the Units and charged to the Owners in accordance with their respective Shares of Common Expenses.

8.3 Telephone. Each Owner will be responsible for obtaining telephone services for its Unit and the Limited Common Elements designed to serve only its Unit and will pay all costs,

expenses, fees, rates and other charges incurred in connection therewith, including, without limitation, any connection fees, directly to the provider of such services.

(b) The Association will determine what, if any, telephone services are necessary for the General Common Elements that serve all of the Units and will be responsible for obtaining those services. The Common Expenses incurred by the Association for those services will be allocated among the Units in accordance with their proportionate Shares of Common Expenses.

8.4 Other Utilities. If the Association incurs Common Expenses for any utility service not described above, or if the manner of providing or metering any utility service described above changes from the manner in which such service is provided or metered as of the date of this Declaration, the Association may allocate the Common Expenses incurred for such new utility service or changed utility service in any reasonable and equitable manner consistent with the Act.

8.5 Limitation on Association's and Declarant's Liability. The Association and Declarant will not be liable for any failure of water service or other utility services to be obtained and paid for by the Association hereunder or for injury or damage to any person or property caused by the elements or by another Owner or person in or upon the Project, or resulting from electricity, water, rain, snow, or ice which may leak or flow from outside or from any part of any Building or its drains, pipes, conduits, appliances, or equipment, or from any other place, unless caused by the grossly negligent or willful misconduct of the Association. No diminution or abatement of any assessment under this Declaration will be claimed or allowed for inconvenience or discomfort arising from the making of any repairs or improvements to or maintaining the Project or any part thereof, or from any action taken to comply with the provisions of this Declaration or with the laws, ordinances, regulations, rules, or orders of any governmental authority.

Article 9

MAINTENANCE OF COMMON ELEMENTS AND UNITS

9.1 Maintenance of Common Elements. Except as otherwise provided in this Declaration, the Association, or its duly designated agent, will maintain the Common Elements and the other Association property in good order and condition and will otherwise manage and operate the Common Elements as it deems necessary or appropriate. The Management Committee will have the irrevocable right to have access to each Unit from time to time during reasonable hours as may be necessary for the maintenance, repair or replacement of the Common Elements or for making emergency repairs necessary to prevent damage to the Common Elements or to another Unit or Units. In addition, the Association will ensure that all interior Common Elements are sufficiently heated to prevent the freezing of water and sewer lines serving the Condominium Project. Without the limiting the foregoing, the Association may:

(a) construct, modify, add to, repair, replace, or renovate any improvements that are located on or constitute a part of any Common Element;

- Element;
- (b) plant and replace trees, shrubs, and other vegetation on any Common Element;
 - (c) place, maintain, and replace signs upon any Common Element;
 - (d) adopt and enforce Rules and Regulations regulating the use of Common Elements;
 - (e) keep all exterior light fixtures fitted with working bulbs and provide for their illumination from the evening hours until dawn (photo cell fixtures may be used for this purpose); and
 - (f) take any other actions as the Association deems necessary or advisable to protect, maintain, operate, manage, or regulate the use of the Common Elements.

9.2 Maintenance of Units. Each Owner, at such Owner's sole cost and expense, will maintain in good order and repair its Unit and all utility systems, mechanical systems, sprinkler systems, exhaust, heating and ventilation systems, storage areas, lines, ducts, patios, balconies, decks, porches, courtyards, stoops, tanks, pumps, motors, fans, compressors, plumbing fixtures and in general all other such apparatus (including all fixtures located therein) serving solely such Unit. The Owner will not permit any screws, bolts, or other items to be used upon the Limited Common Elements of a balcony or patio or any other locations which would penetrate the Common Elements. The Owner of a Unit will keep the Limited Common Elements designated for use in connection with his Unit, in a good, clean, sanitary and attractive condition; provided, however, the Association will keep the same in a good state of repair, including without limitation all garage doors (including the interior and exterior surfaces thereof). All such garage doors will be painted, maintained, and/or replaced so as to be in conformity with all others located within the Property. In the event that an Owner fails to keep the Limited Common Elements appurtenant to his Unit, in a good, clean, sanitary and attractive condition, or in the event that the Owner improperly uses or damages the Common Elements adjacent to a Limited Common Element, the Association may cause the Limited Common Element to be properly maintained and the Common Elements to be restored to its proper condition, at the expense of the Owner, in accordance with the procedures set forth herein. The Association will have no obligation regarding maintenance or care which is required to be accomplished by any Owner.

9.3 Mechanic's Liens and Indemnification. No labor performed or materials furnished and incorporated into a Unit with the consent or at the request of an Owner or an agent, contractor or subcontractor of an Owner will be the basis either for filing a lien against the Unit of any other Owner not expressly requesting or consenting to the same, or against the Common Elements. Notwithstanding the foregoing, labor performed or materials furnished for the Common Elements, if authorized by the Owners, the manager or the Management Committee in accordance with this Declaration, the Bylaws, the Rules and Regulations, or the Act, will be deemed to be performed or furnished with the express consent of each Owner and will be the basis for filing a lien pursuant to applicable law. Payment for any such lien will be made as provided in the Act. Each Owner will indemnify and hold harmless each of the other Owners and any Mortgagee from and against all liability arising from any claim or lien against the Unit of

any other Owner or against the Common Elements for construction performed or for labor, materials, services or supplies incorporated in the Owner's Unit at the Owner's request.

Article 10

COVENANTS, CONDITIONS, AND RESTRICTIONS

10.1 Applicability of Covenants, Conditions, and Restrictions. Except as otherwise provided in this Declaration, the covenants, conditions, and restrictions set forth in this Article 10 will apply to all Units and Common Elements.

10.2 Association Documents. Each Owner will strictly comply with, and will require its Guests to comply with, all provisions of the Association Documents that apply to such Owner or such Owner's Unit.

10.3 Notice of Conveyance, Assignment, or Encumbrance. Promptly after a conveyance of a fee simple interest in a Unit or portion thereof, the grantee will furnish a copy of the conveyance deed to the Association.

(b) Promptly after an encumbrance of a fee simple interest in a Unit or portion thereof, the Owner will furnish the Association with a copy of the Mortgage creating the encumbrance.

10.4 Use of Units. An Owner of a Unit may use such Unit only as a permanent or vacation single-family residence (as "family" is defined from time to time in the zoning ordinances of South Jordan, Utah) for itself and its Guests. In no event will any Unit be occupied by more than two non-family members. No Owner of a Unit will conduct any business, profession, occupation, or trade from its Unit; provided that this Declaration does not prohibit an Owner from leasing or renting such Owner's Unit to others so long as the use of such Unit complies with the provisions of this Declaration, the Act, and other applicable laws and ordinances. No Unit will be used for conducting the business of the rental of other Units. Any lease or rental of a Unit will be in writing, will be subject to this Declaration and the Bylaws, and will not be for a period less than thirty consecutive days. All obligations of the Owner under and by virtue of the provisions contained in this Declaration will continue, notwithstanding that he may have leased or rented a Unit, but the Owner of a Unit will have no obligation for expenses or other obligations accruing after the date of conveyance of such Unit. In the event of the rental or lease of a Unit, an Owner will be deemed to have granted a license to his tenant(s) of his right to use the Common Areas for the term of the lease or the period of rental, and such Owner will have no right to use the Common Areas during the term or period of such lease or rental.

(b) Notwithstanding the restrictions set forth in Section 10.4(a):

(i) an Owner may use its Unit as its private office, on the condition that the Owner does not invite others to its Unit to conduct business and such use complies with all applicable Federal, State, and local laws, ordinances, regulations, and rules;

(ii) an Owner will have the exclusive right at such Owner's sole cost and expense to maintain, repair, paint, repaint, tile, wax, paper, or otherwise refinish and

decorate the interior surfaces of the walls, ceilings and floors forming the boundaries of such Owner's Unit and all walls, ceilings, floors and doors within such boundaries; and

(iii) the Association and, during the Declarant Control Period, Declarant may use one Unit owned or leased by it as a management office, or a combined management office and residence for a resident manager, for the Condominium Project.

10.5 Use of Common Elements. All Owners and their Guests may use the General Common Elements and the Limited Common Elements designed to serve their Units for the purposes for which such Common Elements are intended. Notwithstanding the preceding sentence, neither an Owner nor a Guest may use any Common Element in any manner that unreasonably interferes with, hinders or encroaches upon the rights of other Owners in and to the Common Elements. Without limiting the generality of the foregoing, no Owner will cause, or permit its Guests to cause, waste to any Common Element.

10.6 Alterations. Except as otherwise expressly provided in this Declaration, an Owner of a Unit may not make any improvement or alteration to a Common Element or any improvement or alteration to its Unit that affects any Common Element or any other Unit, without the prior written consent of the Association. No Unit Owner will do any work or make any alterations or changes which would jeopardize the soundness or safety of the Condominium Project, reduce its value or impair any easement or hereditament, without in every case the unanimous written consent of all Unit Owners being first obtained.

(b) Without limiting the generality of Section 10.6(a), an Owner of a Unit may not, without the prior written consent of the Association, install or erect any improvement, mechanical system, or fixture that either:

(i) protrudes beyond the boundaries of the Owner's Unit; or

(ii) is located wholly outside the Owner's Unit (even if located within a Limited Common Element that is assigned to solely the Owner's Unit), except for the initial landscaping of the private yard area required by Section 9.1.

10.7 Nuisances, Hazardous Activities, and Unsightliness. No Person will conduct any activity on the Land which creates a nuisance.

(b) No Person will conduct any activity on the Land which is or might be hazardous to any Person or property.

(c) No unsightliness will be permitted at the Land.

(d) Normal construction activities will not be considered to violate the terms and conditions of this Section 10.7.

10.8 Signs.No signs whatsoever will be erected or maintained on the Land, except signs identifying the Condominium Project or necessary to its operations and that are approved in writing by the Management Committee, or such signs are required by applicable law.

(b) Without limiting the generality of Section 10.8(a), no "For Sale" or "For Rent" signs will be displayed on the exterior or interior of a Unit.

10.9 Compliance with Laws.Nothing will be done or kept at the Land in violation of any law, ordinance, rule, regulation or other requirement of any governmental or quasi-governmental authority.

10.10 Compliance with Insurance.Except as may be approved in writing by the Association, nothing will be done or kept at the Land that may result in the cancellation of any insurance maintained by the Association or may result in an increase in the rates of any such insurance.

10.11 Subdivision, Rezoning and Timesharing.No Unit may be subdivided, unless the subdivision has been approved by 100 percent of the votes allocated to all Units at a duly convened meeting of the Association and has received all applicable governmental and quasi-governmental approvals.

(b) No application for re-zoning any portion of the Land, and no applications for variances or use permits, will be filed with any governmental or quasi-governmental authority, unless the proposed re-zoning has been approved by 100 percent of the votes allocated to all Units at a duly convened meeting of the Association and the uses that would be permitted under the re-zoning comply with this Declaration and the other Association Documents.

(c) No Owner will offer or sell any interest in any Unit under a "timesharing" or "interval ownership" plan or similar plan.

(d) The covenants, conditions and restrictions set forth in Sections 10.11(a) and (b) above will not apply to Declarant's development of the Land or Declarant's exercise of any Special Declarant Right.

10.12 Vehicles and Parking.No motor vehicle classed by manufacturer rating as exceeding three-quarter ton and no mobile home, trailer, detached camper or camper shell, boat, or other similar equipment or vehicle may be kept or parked at the Condominium Project.

(b) No motor vehicle will be constructed, repaired or serviced at the Condominium Project.

(c) Owners will park in the driveway or garages associated with their Unit only.

(d) An Owner will not sell, lease or otherwise convey all or any part of the parking rights it has by virtue of its ownership of a Unit (other than in connection with the sale, lease or other conveyance of such Owner's Unit).

10.13 Deliveries, Trash Removal, and Other Services. Unless otherwise directed by the Association, Owners of Units and their Guests will place all trash and other waste from the Units in receptacles which are located within the Condominium Project and designated for that purpose.

10.14 Exterior Storage. No Owner will store any materials or items on or in any Common Element, other than those Common Elements designed for that purpose, such as storage lockers, and then only in strict accordance with the terms and conditions of the Association Documents.

10.15 Animals. No animals, livestock or poultry of any kind will be raised, bred, or kept in or on the Property or in any Unit, except that an Owner may have up to two (2) (total) domestic dogs, cats, fish or birds; provided (a) the Owner abides by the Rules and Regulations pertaining to the maintenance and care of pets; (b) the cat may not weigh more than twenty pounds and the dog is not any of the restricted breeds identified below; and (c) the dog or cat does not have a propensity for violence. No cat or dog enclosure will be erected, placed or permitted to remain on any portion of the Common Elements, nor will any cat or dog be tied to any structure outside of a Unit. The keeping of any dog or cat will be subject to the Rules and Regulations. Any cat or dog will be on a leash at all times said cat or dog is outside of a Unit. No cat or dog will be permitted to defecate on any portion of the Common Elements, and the Owner of such dog or cat will immediately remove feces left upon the Common Elements by his or her cat or dog. If any Owner fails to abide by the Rules and Regulations and/or covenants applicable to the keeping of pets, the Management Committee may bar such Owner's dog or cat from the use of or travel upon the Common Elements and impose a Default Assessment by reason of such violation. If any dog or cat endangers the health of any Owner or creates a nuisance or unreasonable disturbance, as may be determined in the sole discretion of the Committee, said cat or dog must be removed from the Property upon seven days written notice from the Management Committee. The following breeds of dog are restricted breeds: pure breeds or mixed breed of any of the following: Afghan Hound, Akita, Australian Cattle Dog, Basenji, Basset Hound, Bedlington Terrier, Bernese, Bloodhound, Boxer, Bulldog, Chow, Dalmatian, Doberman, Dog de Bordeaux, Elkhound, Fila Brasileiro, Foxhound, German Shepherd, Great Dane, Greyhound, Husky, Keeshond, Malamute, Mastiff, Pit Bull, Presa Canario (Pit Bull Family) Pointer, Rottweiler, Saint Bernard, Saluki and Weimaraner.

10.16 Notification of Allowed Smoking and Indemnification. Smoking is allowed in the Units and tobacco smoke may drift from one Unit into another and each Owner is hereby informed and acknowledges by purchasing said Owner's Unit that such drifting may occur. Each Owner will contain tobacco smoke created within such Owner's Unit within the Owner's Unit and will install at such Owner's sole cost and expense, such air filtration systems as are necessary to contain such smoke and the odors created thereby to such Owner's Unit. Each Owner will indemnify and hold Declarant and the Association harmless from and against any and all liabilities, obligations, claims, debts, demands, suits, costs, attorneys' fees, expenses, actions and causes of action of any kind or nature whatsoever, in law or equity, arising out of or in any way relating to such Owner's violation of the covenants, conditions and restrictions stated in this Article 9, including, without limitation, any liability, claim demand or action arising out the failure of such Owner to contain tobacco smoke within such Owner's Unit.

10.17 Declarant's Exemption. Nothing contained in this Declaration or in any other Association Document will be construed to prevent:

- (a) Declarant's exercise and enjoyment of any Special Declarant Right or any other rights of Declarant under this Declaration or any other Association Document; or
- (b) the conduct by Declarant or its employees or agents of any activity, including, without limitation, the erection or maintenance of temporary structures, improvements or signs, necessary or convenient to the development, construction, marketing or sale of property within or adjacent to the Condominium Project.

**Article 11
EASEMENTS AND RESERVATIONS**

11.1 Declarant's Easements Over Common Elements. In accordance with the Act, Declarant hereby reserves for itself, its successors and assigns a general, transferable easement over, across, through and under the Common Elements to:

- (i) discharge Declarant's obligations under this Declaration;
- (ii) exercise any of Declarant's rights under this Declaration; and
- (iii) make improvements on the Land or any other real estate owned by Declarant, for the purpose of doing all things reasonably necessary and proper in connection with the foregoing.

(b) Declarant hereby reserves for itself, its successors and assigns, the right to:

- (i) establish from time to time utility and other easements, permits or licenses over, across, through and under the Common Elements for the benefit of the Condominium Project or any property owned by Declarant; and
- (ii) create other reservations, exceptions and exclusions for the best interest of the Declarant and other Persons, on the conditions that (A) the parties benefitted by the easement, license, permit, reservation, exception or exclusion must use reasonable efforts to locate any such easement, license, permit reservation, exception or exclusion to minimize interference with the use of the Land by the Owners to the extent practicable; and (B) if the parties benefitted by the easement, license, permit, reservation, exception or exclusion construct or install any improvements on the Land pursuant to the same, the benefitted parties will promptly repair any damage caused to the Land thereby at their sole cost and expense.

11.2 Utility Easement. Subject to the terms and conditions of this Declaration and all other Association Documents, Declarant hereby creates a general easement over, across, through and under the Land for ingress to, egress from, and installation, replacement, repair and maintenance of, all utility and service lines and systems, including, without limitation, water, sewer, gas, telephone, electricity and cable communication that service the Land or any portion thereof. The Association may, but is not obligated to, authorize the release of portions of the

general easement created pursuant to this Section 11.2 upon the request of any Owner showing good cause therefor.

(b) Pursuant to this easement, a utility or service company may install and maintain facilities and equipment on the Land and affix and maintain wires, circuits, and conduits on, in, and under the roofs and exterior walls of Improvements to provide service to the Units or the Common Elements. Notwithstanding anything to the contrary contained in this Section 11.2, no sewers, electrical lines, water lines, or other utilities or service lines may be installed or relocated on any portion of the Land, except in accordance with the terms and conditions of Sections 10.7 through 10.10. Any utility or service company using this general easement will use its best efforts to install, repair, replace and maintain its lines and systems without disturbing the uses of Owners, the Association, Declarant and other utility and service companies. With respect to the sewer laterals, the Association shall own, operate and maintain the same and, as between the South Valley Sewer District and the Association, the Association shall have liability for any sewer backup occurring by reason of any obstruction located in such laterals.

(c) If any utility or service company furnishing utilities or services to the Land or any portion thereof as permitted under Section 11.2(a) above requests a specific easement by separate recordable document, the Association will have the right and authority, but not the obligation, to grant such easement over, across, through and under any portion of the Land.

11.3 Association's Easement. The Association will have a general easement over, across, through, and under each Unit and each Common Element to:

(i) exercise any right held by the Association under this Declaration or any other Association Document; and

(ii) perform any obligation imposed upon the Association by this Declaration or any other Association Document.

(b) Notwithstanding the foregoing, the Association will not enter any Unit without reasonable prior notice to the Owner thereof, except in cases of emergency.

11.4 Easements for Encroachments.In the event that any portion of the General Common Elements, a Limited Common Element, Unit and/or a Building (whether constructed by Declarant or reconstructed so as to substantially duplicate a Unit or Building originally constructed by Declarant) encroaches or comes to encroach on the General Common Elements, a Limited Common Element, another Unit and/or another Building, as a result of construction, reconstruction, repair, shifting, settlement, or movement of any portion of the foregoing, an easement is created hereby and will exist so long as such encroachment exists, but such easement will not relieve an Owner of liability in the case of willful misconduct.

11.5 Emergency Access Easement.Declarant hereby grants a general easement to all police, sheriff, fire protection, ambulance and all other similar emergency agencies or Persons to enter upon the Land in the proper performance of their duties.

Article 12 INSURANCE

12.1 General Liability Insurance.The Association will obtain and maintain one or more policies of commercial general liability insurance insuring the Owners, the Association, the Management Committee, the manager engaged by the Association, if any, and their respective agents against general liability and claims arising in connection with the ownership, existence, use or management of the Common Elements, in an aggregate amount that is not less than \$1,000,000, or such greater amount as the Management Committee deems appropriate. Such insurance will cover claims of one or more insured parties against other insured parties.

12.2 Property Insurance.The Association will obtain and maintain a master or blanket policy of property insurance coverage for no less than the full insurable replacement cost of all of the Common Elements, subject to reasonable deductibles and exclusive of land, excavations, foundations and similar items normally excluded from property insurance policies. The policy will contain each of the following features, to the extent that such features are, in the reasonable discretion of the Management Committee, available at reasonable cost:

- (a) an agreed-amount endorsement or its equivalent;
- (b) an increased-cost-of-construction endorsement or a contingent-liability-from-operation-of building-laws endorsement or their equivalent;
- (c) an extended-coverage endorsement;
- (d) vandalism and malicious mischief coverage;
- (e) a special-form endorsement; and
- (f) a determinable-cash-adjustment clause or a similar clause to permit cash settlement covering full value of the Common Elements in case of partial destruction and a decision not to rebuild.

The policy will also contain land movement/soils subsidence endorsement or its equivalent.

12.3 Worker's Compensation Insurance. The Association will obtain and maintain for the benefit of and on behalf of the Association workmen's compensation and employer's liability insurance and all other similar insurance with respect to employees of the Association in the amounts and in the forms now or hereafter required by law.

12.4 Additional Provisions to be Contained in Insurance Policies. Any insurance policies obtained and maintained by the Association pursuant to Sections 12.1 through 12.3 will name as insureds the Association and the Owners (including Declarant, so long as Declarant is the Owner of any Unit) and provide that:

(a) the insurer waives its right of subrogation under the policy against any Owner or member of the Owner's household;

(b) no act or omission by any Owner, unless acting within the scope of such Owner's authority on behalf of the Association, will void the policy or be a condition to recovery under the policy; and

(c) if, at the time of a loss under the policy, there is other insurance in the name of an Owner covering the same risk covered by the policy, the Association's policy provides primary insurance.

12.5 **Trustee.** Any loss covered by the property insurance policy described in Section 12.2 must be adjusted with the Association, and the insurance proceeds for that loss will be payable to the Association or any insurance trustee designated for that purpose, and not to any Owners or Mortgagees. The insurance trustee or the Association will hold any insurance proceeds in trust for the Owners and Mortgagees as their interests may appear. Subject to the provisions of Section 13.2, the proceeds must be disbursed first for the repair or restoration of the damaged property, and the Owners and Mortgagees are not entitled to receive payment of any portion of the proceeds unless there is a surplus of proceeds after the Condominium Project has been repaired or restored or the Condominium Project is terminated.

12.6 **Individual Property Insurance Limited.** Each Owner will have the right to separately insure its Unit and its personal property against loss by fire or other casualty. In addition, any Improvements made by an Owner within its Unit may be separately insured by the Owner, but the insurance is to be limited to the type and nature of coverage commonly known as "tenant's improvements." All such insurance that is individually carried must contain a waiver of subrogation rights by the insurer as to other Owners, the Association, Declarant, and Mortgagees.

12.7 **Fidelity Insurance Bond.** The Association may purchase for the benefit of and on behalf of the Association, in amounts not less than three months assessments for all Units, and in such forms as it deems appropriate, fidelity insurance or a bond to cover against dishonesty of Management Committee members, Officers, employees and others who hold or administer funds, destruction or disappearance of money or securities, and forgery. The fidelity policy or bond will name the Association as the insured.

12.8 **Management Committee's Authority to Revise Insurance Coverage.** Subject to any restrictions imposed by the Act, the Management Committee will have the power and right to deviate from the insurance requirements contained in this Article 12 in any manner that the Management Committee, in its discretion, considers to be in the best interests of the Association. If the Management Committee elects to materially reduce the coverage from the coverage required in this Article 12, the Management Committee will make all reasonable efforts to notify the Owners of the reduction in coverage and the reasons therefor at least thirty days before the effective date of the reduction.

(b) The Association and its Directors and Officers will have no liability to any Owner or Mortgagee if, after a good faith effort, (i) the Association is unable to obtain any insurance required hereunder because the insurance is no longer available; or (ii) if available, the insurance can be obtained only at a cost that the Management Committee, in its sole discretion, determines is unreasonable under the circumstances.

(c) The Management Committee is authorized to negotiate and agree on the value and extent of any loss under any policy carried by the Association, including, but not limited to, the right and authority to compromise and settle any claim or enforce any claim by legal action or otherwise and to execute releases in favor of any insurer.

(d) Each Owner, by acceptance of a deed to a Unit irrevocably appoints the Association as that Owner's attorney in fact for purposes of procuring, negotiating, accepting,

compromising, releasing, settling, distributing, and taking other related actions in connection with any insurance policy maintained by the Association and any losses or claims related thereto and agrees to be bound by the actions so taken as if the Owner had personally taken the action.

12.9 Periodic Insurance Review. The Management Committee periodically (and not less than once every three years) will review the Association's insurance policies and make such adjustments to the policies' terms and conditions as the Management Committee considers to be in the best interests of the Association. The review will include an appraisal by a qualified appraiser of the current replacement costs of all covered property under the Association's policy unless the Management Committee is satisfied that the current dollar limit of the property policy, coupled with the amount of actual reserves on hand, is equal to or greater than the current replacement costs.

Article 13 CASUALTY

13.1 Total or Partial Destruction of the Condominium Project. If there is a total or partial destruction of the Condominium Project, the Condominium Project will be promptly rebuilt or repaired in accordance with the Act, unless:

- (a) the Condominium Project is terminated in accordance with Section 18.2;
- (b) repair or replacement would be illegal under any state or local statute governing health or safety;
- (c) seventy-five percent or more of the Building is destroyed or substantially damaged, and the Owners, by a vote of at least seventy-five percent of the Interests in Common Elements, do not voluntarily, within 100 days after the occurrence of such damage, make provision for reconstruction, and the Management Committee will Record, in the Salt Lake County Records, a notice, in accordance with the Act, thereby subjecting the Condominium Project to an action for partition and sale; or
- (d) the Owners, by a vote of at least seventy-five percent of the Owners of the Interests in the Common Element, elect to sell or otherwise dispose of the Condominium Project in accordance with the Act.

13.2 **Excess Insurance Proceeds.**If the entire Condominium Project is not repaired or replaced, the insurance proceeds attributable to the damaged Common Elements must be used to restore the damaged area to a condition compatible with the remainder of the Condominium Project, and, except to the extent that other persons will be distributees, the insurance proceeds attributable to Units and Limited Common Elements that are not rebuilt must be distributed to the Owners of those Units and the Owners of the Units to which those Limited Common Elements were allocated, or to Mortgagees, as their interests may appear, and the remainder of the proceeds, if any, must be distributed to all the Owners or Mortgagees, as their interests may appear, in proportion to the Interests in Common Elements of all the Units.

13.3 **Casualty to a Unit.**To the extent that the Association is not obligated to make any such repairs or replacements, each Owner will repair or replace any damage to or destruction to the interior of its Unit, as soon as is reasonably practical after such damage or destruction occurs.

Article 14 CONDEMNATION

14.1 **Condemnation of All Units.**If the entire Condominium Project is taken by condemnation, eminent domain or similar proceeding, the Condominium Project will terminate as of the date of the taking and any condemnation award payable in connection therewith will be paid to the Association and then disbursed by the Association to the Owners in proportion to their Interests in the General Common Elements.

14.2 **Condemnation of Fewer Than All Units.**If one or more Units, but less than the entire Condominium Project, is taken by condemnation, eminent domain or similar proceeding,

(a) any condemnation award payable in connection therewith will be paid,
and

(b) the Interest in Common Elements appurtenant to those Units will be reallocated, in accordance with the terms and conditions of the Act.

14.3 **Condemnation of Common Elements.**If any portion of the Common Elements is taken by condemnation, eminent domain or similar proceeding, any condemnation award payable in connection therewith will be paid to the Association and then disbursed by the Association to the Owners in proportion to their Interests in the General Common Elements.

Article 15 SPECIAL DECLARANT RIGHTS

15.1 **Improvements.**Declarant hereby reserves for itself, its successors and assigns the right, but is not obligated, to construct:

(a) any Improvements shown on the Plat; and

(b) any other buildings, structures, or improvements that Declarant desires to construct on the Land, or any other real estate owned by Declarant, regardless of whether the same ever become part of the Condominium Project.

15.2 Development Rights. Declarant hereby reserves for itself, its successors and assigns the right to create easements, permits, licenses and other property rights and reservations as described in Article 2 and Article 10 of this Declaration.

15.3 Sales Offices and Models. Notwithstanding anything in the Declaration to the contrary, during the Declarant Control Period, Declarant will have the following rights in furtherance of any sales, promotional, or other activities designed to accomplish or facilitate the sale of all Units owned or to be owned by Declarant.

(a) Declarant will have the right to maintain four or less sales offices or model Units. Such offices and/or model Units may be one or more Units (of any floor area and at any location) owned by it, one or more separate structures or facilities placed on the Land for the purpose of aiding Declarant's sales efforts, a room or rooms in the Common Elements, or any combination of the foregoing. If one or more structures or facilities is so utilized by Declarant, each will be reasonably located given the layout of the Condominium Project and each will have an aggregate floor area not substantially in excess of the aggregate floor area of the largest Unit contained in the Condominium Project.

(b) Declarant will have the right to maintain a reasonable number of promotional, advertising, and/or signs, banners, or similar devices at any place or places on the Land, but any such device will be of a size and in a location as is reasonable and customary.

(c) Declarant will have the right from time to time to locate or relocate any of its sales offices, model Units, and/or signs, banners, or similar devices, but in connection with such location or relocation will observe the limitations imposed by the preceding portion of this Section. Within a reasonable period after the end of the Declarant Control Period, Declarant will have the right to remove from the Condominium Project any signs, banners, or similar devices and any separate structure or facility which was placed on a portion of the Land for the purpose of aiding Declarant's sales efforts. Any signs, banners, or similar devices, and any separate structure or facility for aiding Declarant's sales efforts will comply with applicable zoning ordinances.

15.4 Exercising Special Declarant Rights.Declarant may exercise its Special Declarant Rights at any time prior to the later to occur of the date on which the Declarant Control Period expires or the date that is fifty years after the date on which this Declaration is recorded in the Salt Lake County Records. Declarant may exercise its Special Declarant Rights in any order, and no assurance is given as to the order in which Declarant will exercise its Special Declarant Rights. If Declarant exercises any Special Declarant Right with respect to any portion of the Land, Declarant may, but is not obligated to, exercise that Special Declarant Right with respect to any other portion of the Land. Notwithstanding anything to the contrary contained in this Declaration, Declarant may exercise any Special Declarant Right described in this Article 14 and any other right reserved to Declarant in this Declaration, without the consent of the Association or any of the Owners.

15.5 Interference with Special Declarant Rights.Neither the Association nor any Owner may take any action or adopt any Rule or Regulation that interferes with or diminishes any Special Declarant Right, without Declarant's prior written consent. Any action taken in violation of this Section 15.5 will be null and void and have no force or effect.

15.6 Rights Transferable.Declarant may transfer any Special Declarant Right reserved to it under this Article 14 or under any other provision of this Declaration in accordance with the terms and conditions of the Act.

Article 16 MORTGAGEE PROTECTIONS

16.1 Benefit of Mortgagees.This Article establishes certain standards and covenants which are for the benefit of Mortgagees. This Article is supplemental to, and not in substitution of, any other provisions of this Declaration, but in the case of any conflict, this Article will control.

16.2 Notice of Actions.If requested in writing to do so, the Association will give prompt written notice of the following to each First Mortgagee making such request:

- (a) any condemnation loss or any casualty loss which affects a material portion of the Common Elements or any Unit in which an interest is held by the First Mortgagee;
- (b) any delinquency in the payment of Assessments which remains uncured for sixty days by an Owner whose Unit is encumbered by a First Mortgage held by such First Mortgagee;
- (c) any lapse, cancellation, or material modification of any insurance policy or fidelity bond maintained by the Association;
- (d) any proposed action which would require the consent of First Mortgagees as set forth in this Article; and
- (e) any judgment rendered against the Association.

16.3 Consent Required. Notwithstanding anything to the contrary contained in this Declaration, the Association may not take any of the following actions without the consent of sixty-seven percent of the First Mortgagees (based on one vote for each Unit covered by a First Mortgage):

(a) by act or omission seek to abandon or terminate the Condominium Project, except after condemnation or substantial casualty;

(b) except as provided herein for condemnation, casualty, the conversion of the Convertible Land, and the exercise of Special Declarant Rights, change the Interests in Common Elements, Shares of Common Expenses or votes in the Association of any Unit;

(c) subdivide, partition, or relocate the boundaries of any Unit, except as permitted with respect to Special Declarant Rights;

(d) abandon, subdivide, partition, encumber, sell, or transfer the Common Elements (the granting of easements for public utilities or for other purposes provided for in this Declaration will not be deemed transfers);

(e) use property insurance proceeds for losses to any portion of the Common Elements for other than repair, replacement, or reconstruction of such Common Elements, except as provided by this Declaration; or

(f) merge the Condominium Project with any other common interest community.

16.4 Notice of Objection. Unless a First Mortgagee provides the Association with written notice of its objection, if any, to any proposed amendment or action requiring the approval of First Mortgagees within thirty days following the receipt of notice of such proposed amendment or action, the First Mortgagee will be deemed conclusively to have consented to or approved the proposed amendment or action.

16.5 First Mortgagee's Rights. First Mortgagees, jointly or singly, may pay taxes or other charges which are in default and which may or have become a charge against any of the Common Elements or improvements thereon, and may pay overdue premiums on hazard insurance policies, for the Common Elements. First Mortgagees making such payment will be owed immediate reimbursement from the Association.

(b) A First Mortgagee will be entitled to cure any delinquency of the Owner of a Unit encumbered by its First Mortgage in the payment of Assessments. In that event, the First Mortgagee will be entitled to obtain a release from the lien imposed or perfected by reason of such delinquency.

16.6 Limitations on First Mortgagee's Rights. No requirement for approval or consent by a First Mortgagee provided in this Article will operate to:

(a) deny or delegate control over the general administrative affairs of the Association by the Owners or the Management Committee;

(b) prevent the Association or the Management Committee from commencing, intervening and/or settling any legal proceeding; or

(c) prevent any insurance trustee or the Association from receiving and distributing any insurance proceeds in accordance with the requirements of Article 11.

16.7 **Declarant Rights.**No provision or requirement of this Article 15 will apply to any Special Declarant Rights or other rights reserved to Declarant in this Declaration.

16.8 **Mortgagee Rights in Insurance or Condemnation Proceeds Unaffected.**Notwithstanding any other provision contained herein to the contrary, this Declaration will not be deemed to give an Owner, or any other party, priority over the rights of a First Mortgagee, with respect to a Condominium Unit in which it has an interest, upon payment to an Owner of insurance proceeds or condemnation awards for losses to or a taking of said Owner's Condominium Unit and/or with respect to said Owner's interest in the Common Elements.

Article 17 ENFORCEMENT AND REMEDIES

17.1 **Enforcement.**Each provision of this Declaration with respect to the Association or the Common Elements will be enforceable by Declarant or by any Owner by a proceeding for injunctive relief.

(b) Each provision of this Declaration with respect to an Owner or a Unit will be enforceable by Declarant or by the Association by:

(i) a proceeding for injunctive relief;

(ii) a suit or action to recover damages; or

(iii) in the discretion of the Association, for so long as any Owner fails to comply with any such provisions, exclusion of such Owner and its Guests from the use of any Common Elements and from participation in any Association affairs.

(c) In addition to the rights and remedies described in Section 17.1(b), if an Owner fails to strictly perform or observe any covenant or condition to be performed or observed by such Owner under this Declaration or any other Association Document, the Association will have the following rights and remedies:

(i) The Association may, but is not obligated to, cure such failure to comply at the Owner's sole cost and expense. If the Association cures any such failure to comply, the Owner will pay to the Association the amount of all costs incurred by the Association in connection therewith within thirty days after the Owner receives a written invoice therefor from the Association.

(ii) The Association may, after notice and an opportunity to be heard, fine the Owner, as a Default Assessment, an amount not to exceed \$100 for each violation. The

Owner will pay any such fine to the Association within thirty days after the Owner receives written invoice therefor from the Association.

(iii) With respect to an Owner's failure to pay an installment of any Assessment, the Association may accelerate the due date for the payment of the full amount of the Assessment.

(iv) The Association will have all other rights and remedies available to it under this Declaration, at law or in equity.

(d) All rights and remedies of the Association will be cumulative and the exercise of one right or remedy will not preclude the exercise of any other right or remedy.

17.2 Attorneys' Fees.In the event of any dispute under or with respect to this Declaration or any other Association Document, the prevailing party will be entitled to recover from the non-prevailing party all of its costs and expenses in connection therewith, including, without limitation, the fees and disbursements of any attorneys, accountants, engineers, appraisers or other professionals engaged by the prevailing party.

17.3 Interest.If an Owner fails to pay to the Association any Assessment or other amount due to the Association as and when the same becomes due, the Owner will pay to the Association interest on such unpaid amount at the rate of eighteen percent per annum, or such other rate as the Management Committee may establish from time to time, from the due date of such unpaid amount until the date paid.

17.4 Right to Notice and Hearing.Whenever an Association Document requires that an action be taken after "notice and hearing," the following procedure will be observed. The party proposing to take the action (e.g., the Management Committee or a committee or officer of the Association) will give at least three days' prior written notice of the proposed action to all Owners whose interests would be significantly affected by the proposed action, as reasonably determined by the proposing party. The notice will include a general statement of the proposed action and the date, time and place of the hearing. At the hearing, the party proposing to take the action, and all affected Owners may give testimony orally, in writing or both (as specified in the notice), subject to reasonable rules of procedure established by the party conducting the hearing to assure a prompt and orderly resolution of the issues. Such evidence will be considered in making the decision but will not bind the decision makers. Any affected Owner will be notified of the decision in the same manner in which notice of the hearing was given. Any Owner having a right to notice and hearing will have the right to appeal to the Management Committee from a decision of a proposing party other than the Management Committee. Such right of appeal may be exercised within ten days after an Owner receives notice of the decision, by filing a written notice of appeal with the Management Committee. The Management Committee will conduct a hearing within forty-five days thereafter, giving the same notice and observing the same procedures as were required for the original hearing.

17.5 Non-waiver.Failure by Declarant, the Association or any Owner to enforce any covenant, condition, restriction, reservation, easement, assessment, charge, lien or other

provision of this Declaration or any other Association Document will in no way be deemed to be a waiver of the right to do so thereafter.

Article 18
TERM AND AMENDMENTS

18.1 **Term.**The covenants, conditions, restrictions, reservations, easements, assessments, charges, and liens set forth in this Declaration will run with and bind the Land until the Declaration is terminated pursuant to Section 18.2.

18.2 **Termination.**Subject to the rights of Mortgagees under Article 16, the Owners may terminate the Condominium Project and this Declaration, by the vote of 100 percent of the votes allocated to all Units. If the necessary votes are obtained, the agreement of the Owners to terminate the Condominium Project and this Declaration will be evidenced by a termination agreement or ratification thereof, executed by the required number of Owners in accordance with the Act. Upon recordation of the termination agreement in the Salt Lake County Records, the Condominium Project will be terminated, this Declaration will have no further force or effect, and the Association will be dissolved. Notwithstanding the foregoing, the Owners may not terminate the Condominium Project during the Declarant Control Period without Declarant's prior written consent, which consent Declarant may withhold in its sole discretion.

18.3 **Amendments.**Except as otherwise expressly provided in this Declaration or the Act, and except for provisions of this Declaration regarding the rights and obligations of Declarant, which may not be amended without Declarant's prior written consent, and subject to the rights of Mortgagees under Article 16, Owners may amend any provision of this Declaration at any time by a vote of at least sixty-seven percent of the votes allocated to all Units. If the necessary votes and consent are obtained, the Association will cause an amendment to the Declaration to be recorded in the Salt Lake County Records. Notwithstanding the foregoing, the Owners may not amend this Declaration during the Declarant Control Period without Declarant's prior written consent, which consent Declarant may withhold in its sole discretion.

Article 19
MISCELLANEOUS

19.1 **Interpretation of the Declaration.**Except for judicial construction, the Association, by its Management Committee, will have the exclusive right to construe and interpret the provisions of this Declaration. In the absence of any adjudication to the contrary by a court of competent jurisdiction, the Association's construction or interpretation of the provisions hereof will be final, conclusive and binding as to all persons and property benefitted or bound by the covenants and the provisions hereof.

19.2 **Severability.**Any determination by any court of competent jurisdiction that any provision of this Declaration is invalid or unenforceable will not affect the validity and enforceability of any other provision hereof.

19.3 **Disclaimer of Representations.**Notwithstanding anything to the contrary contained in this Declaration, Declarant makes no warranties or representations whatsoever that

the plan presently envisioned for the complete development of the Condominium Project can or will be carried out or that any land now owned or hereafter acquired by Declarant is or will be subject to this Declaration, or that any such land, whether or not it has been subjected to this Declaration, is or will be committed to or developed for a particular use, that such use will continue in effect.

19.4 Reference to Declaration and Deeds.Deeds to and instruments affecting any Unit or any other part of the Condominium Project may contain the provisions set forth herein by reference to this Declaration, but regardless of whether any such reference is made in any deed or instrument, each and all of the covenants, conditions, restrictions, reservations, easements, assessments, charges and liens set forth herein will be binding upon the grantee-owner or other person claiming through any deed or other instrument and his heirs, executors, administrators, successors and assigns.

19.5 Successors and Assigns of Declarant.Any reference in this Declaration to Declarant will include any successors or assignees of Declarant's rights and powers hereunder on the condition that Declarant's rights and powers may only be assigned by a written recorded instrument expressly assigning such rights and powers.

19.6 Captions and Titles.All captions and titles of headings of Articles and Sections in this Declaration are for the purpose of reference and convenience and are not to be deemed to limit, modify or otherwise affect any of the provisions hereof or to be used in determining the intent or context thereof.

19.7 Exhibits.All exhibits attached to this Declaration are a part of, and are incorporated into, this Declaration.

19.8 Governing Law.This Declaration will be governed by and construed in accordance with Utah law.

19.9 Notices.All Owners of each Unit will have one and the same registered mailing address to be used by the Association or other Owners for notices, demands, and all other communications regarding Association matters. The Owner or the representative of the Owners of a Unit will furnish such registered address to the secretary of the Association within ten days after transfer of title to the Unit to such Owner or Owners. Such registration will be in written form and signed by all of the Owners of the Unit or by such persons as are authorized to represent the interests of all Owners of the Unit. If no address is registered or if all of the Owners cannot agree, then the address of the Unit will be deemed their registered address of the Owner(s), and any notice will be deemed duly given if delivered to the Unit. All notices and demands intended to be served upon the Association will be sent to the following address or such other address as the Association may designate from time to time by notice to the Owner(s):

19.11 **Gender and Number.**

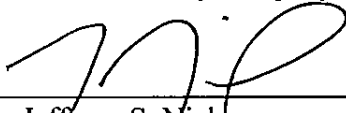

BYLAWS
OF
SAN TROPEZ AT THE SOUTH DISTRICT
CONDOMINIUM ASSOCIATION, INC.

ARTICLE 1
DEFINITIONS

1.01 Declaration.

As used herein, "Declaration" means the Declaration of Condominium for San Tropez at the South District Condominiums, recorded in the Official Records of Salt Lake County, Utah.

1.02 Other Definitions.

Unless otherwise defined herein, all capitalized terms used herein shall have the meanings given to them in the Declaration.

ARTICLE 2
OFFICES

The Association is a Utah non-profit corporation, with its principal office located at 175 East 400 South, Suite 160, Salt Lake City, Utah 84111.

ARTICLE 3
VOTING, QUORUM, AND PROXIES

3.01 Voting.

Votes shall be allocated as set forth in Section 5.1 of the Declaration.

3.02 Quorum.

Except as otherwise required by law or by the Articles, the presence in person or by proxy of Owners entitled to vote more than thirty-five percent (35%) of the total votes of the Owners shall constitute a quorum.

3.03 Proxies.

Votes may be cast in person or by proxy. Every proxy must be executed in writing by the Owner or his duly authorized attorney-in-fact. Such proxy shall be filed with the secretary of the Association before or at the time of the meeting. No proxy shall be valid after the expiration of eleven months from the date of its execution unless otherwise provided in the proxy.

3.04 Majority Vote.

At any meeting of the Owners, if a quorum is present, the affirmative vote of a majority of the votes represented at the meeting, in person or by proxy, shall be the act of the Owners, unless the vote of a greater number is required by law, the Articles, the Declaration, or these Bylaws.

**ARTICLE 4
ADMINISTRATION**

4.01 Annual Meeting.

The annual meeting of the Owners shall be held at a time designated by the Management Committee in the month of November in each year, or at such other date designated by the Management Committee, beginning with the year 2009, for the purpose of electing Directors and for the transaction of such other business as may come before the meeting.

4.02 Special Meetings.

Special meetings of the Owners, for any purpose, unless otherwise prescribed by statute, may be called by the president or by a majority of the Directors and shall be called by the president at the request of Owners entitled to vote twenty percent (20%) or more of the total votes of all Owners.

4.03 Place of Meeting.

The Management Committee may designate the Association's principal offices or any place within Salt Lake County, Utah, as the place for any annual meeting or for any special meeting called by the Management Committee.

4.04 Notice of Meeting.

Written or printed notice of any meeting of the Owners, stating the place, day, and hour of the meeting and the purpose or purposes for which the meeting is called, shall be delivered personally or by mail to each Owner entitled to vote at such meeting not less than ten nor more than fifty days before the date of the meeting. If mailed, such notice shall be deemed to be delivered when deposited in the United States mail, addressed to the Owner at his address as it appears in the office of the Association, with postage thereon prepaid. For the purpose of determining Owners entitled to notice of or to vote at any meeting of the Owners, the Management Committee may set a record date for such determination of Owners, in accordance with the laws of the State of Utah. If requested by the person or persons lawfully calling such meeting, the secretary shall give notice thereof at the expense of the Association.

4.05 Informal Action by Owners.

Any action required or permitted to be taken at a meeting of the Owners may be taken without a meeting if a consent in writing, setting forth the action so taken, shall be signed by all of the Owners entitled to vote with respect to the subject matter thereof. Such consent shall have the same force and effect as a unanimous vote of the Owners.

**ARTICLE 5
DECLARANT CONTROL**

Declarant shall be entitled to control the Association as set forth in Section 6.3 of the Declaration.

**ARTICLE 6
MANAGEMENT COMMITTEE**

6.01 Number and Election of Directors.

Directors shall be appointed, elected, and removed as set forth in Article 6 of the Declaration.

6.02 Resignations; Vacancies.

Any Director may resign at any time by giving written notice to the president or to the secretary of the Association. Such resignation shall take effect at the time specified therein and, unless otherwise specified therein, the acceptance of such resignation shall not be necessary to make it effective. Other than with respect to a Director appointed by the Declarant during the Declarant Control Period, any vacancy occurring on the Management Committee (by reason of resignation or death) may be filled by the affirmative vote of a majority of the Directors then in office though less than a quorum. A vacancy occurring on the Management Committee created by the resignation or death of a Director appointed by the Declarant during the Declarant Control Period shall be filled by the Declarant appointing a new Director. A Director elected to fill a vacancy shall hold office until the next annual meeting of the Owners and until his successor is duly elected and qualified.

6.03 Regular Meetings.

Regular meetings of the Management Committee may be held without call or formal notice at such places within or outside the State of Utah, and at such times as the Management Committee from time to time by vote may determine. Any business may be transacted at a regular meeting. The regular meeting of the Management Committee for the election of Officers and for such other business as may come before the meeting may be held without call or formal notice immediately after, and at the same place as, the annual meeting of Owners, or any special meeting of Owners at which a Management Committee is elected.

6.04 Special Meetings.

Special meetings of the Management Committee may be held at any place within the State of Utah or by telephone, provided that each Director can hear each other Director, at any time when called by the president, or by two or more Directors, upon the giving of at least three days' prior notice of the time and place thereof to each Director by leaving such notice with such Director or at such Director's residence or usual place of business, or by mailing it prepaid and addressed to such Director at such Director's address as it appears on the books of the Association, or by telephone. Notices need not state the purposes of the meeting. No notice of any adjourned meeting of the Directors shall be required.

6.05 Quorum.

A majority of the number of Directors fixed by these Bylaws, as amended from time to time, shall constitute a quorum for the transaction of business, but a lesser number may adjourn any meeting from time to time. When a quorum is present at any meeting, a majority of the Directors in attendance shall, except where a larger number is required by law, by the Articles, or by these Bylaws, decide any question brought before such meeting.

6.06 Waiver of Notice.

Before, at, or after any meeting of the Management Committee, any Director may, in writing, waive notice of such meeting and such waiver shall be deemed equivalent to the giving of such notice. Attendance by a Director at any meeting of the Management Committee shall be a waiver of notice by such Director except when such Director attends the meeting for the express purpose of objecting to the transaction of business because the meeting is not lawfully called or convened.

6.07 Informal Action by Directors.

Any action required or permitted to be taken at a meeting of the Directors may be taken without a meeting if a consent in writing, setting forth the action so taken, shall be signed by all of the Directors entitled to vote with respect to the subject matter thereof. Such consent shall have the same force and effect as a unanimous vote of the Directors.

**ARTICLE 7
OFFICERS AND AGENTS**

7.01 General.

The Officers of the Association shall be a president (who shall be chosen from among the Directors), one or more vice presidents, a secretary, and a treasurer. The Management Committee may appoint such other officers, assistant officers, committees, and agents, including assistant secretaries and assistant treasurers, as they may consider necessary or advisable, who shall be chosen in such manner and hold their offices for such terms and have such authority and duties as from time to time may be determined by the Management Committee. One person may

hold any two offices, except that no person may simultaneously hold the offices of president and secretary. In all cases where the duties of any officer, agent, or employee are not prescribed by the Bylaws or by the Management Committee, such Officer, agent, or employee shall follow the orders and instructions of the president.

7.02 Removal of Officers.

The Management Committee may remove any Officer, either with or without cause, and elect a successor at any regular meeting of the Management Committee, or at any special meeting of the Management Committee called for such purpose.

7.03 Vacancies.

A vacancy in any office, however occurring, shall be filled by the Management Committee for the unexpired portion of the term.

7.04 President.

The president shall be the chief officer of the Association. The president shall preside at all meetings of the Association and of the Management Committee. The president shall have the general and active control of the affairs and business of the Association and general supervision of its officers, agents, and employees. The president of the Association is designated as the Officer with the power to prepare, execute, certify, and record amendments to the Declaration on behalf of the Association.

7.05 Vice Presidents.

The vice presidents shall assist the president and shall perform such duties as may be assigned to them by the president or by the Management Committee. In the absence of the president, the vice president designated by the Management Committee or (if there be no such designation) designated in writing by the president shall have the powers and perform the duties of the president. If no such designation shall be made, all vice presidents may exercise such powers and perform such duties.

7.06 Secretary.

The secretary shall:

- (a) keep the minutes of the proceedings of the Owners Meetings and of the Management Committee Meetings;
- (b) see that all notices are duly given in accordance with the provisions of these Bylaws, the Declaration, and as required by law;
- (c) be custodian of the corporate records and of the seal of the Association and affix the seal to all documents when authorized by the Management Committee;

(d) maintain at the Association's principal offices a record containing the names and registered addresses of all Owners, the designation of the Unit owned by each Owner, and, if such Unit is mortgaged, the name and address of each Mortgagee; and

(e) in general, perform all duties incident to the office of secretary and such other duties as from time to time may be assigned to him by the president or by the Management Committee. Assistant secretaries, if any, shall have the same duties and powers, subject to supervision by the secretary.

7.07 Treasurer.

The treasurer shall be the principal financial officer of the Association and shall have the care and custody of all funds, securities, evidences of indebtedness, and other personal property of the Association and shall deposit the same in accordance with the instructions of the Management Committee. The treasurer shall receive and give receipts and acquittances for moneys paid in on account of the Association, and shall pay out of the funds on hand all bills, payrolls, and other just debts of the Association of whatever nature upon maturity. The treasurer shall perform all other duties incident to the office of the treasurer and, upon request of the Management Committee, shall make such reports to it as may be required at any time. The treasurer shall, if required by the Management Committee, give the Association a bond in such sums and with such sureties as shall be satisfactory to the Management Committee, conditioned upon the faithful performance of his duties and for the restoration to the Association of all books, papers, vouchers, money, and other property of whatever kind in his possession or under his control belonging to the Association. He shall have such other powers and perform such other duties as may be from time to time prescribed by the Management Committee or the president. The assistant treasurers, if any, shall have the same powers and duties, subject to the supervision of the treasurer.

**ARTICLE 8
EVIDENCE OF OWNERSHIP, REGISTRATION OF
MAILING ADDRESS, AND LIEN HOLDERS**

8.01 Proof of Ownership.

Except for those Owners who initially contracted to purchase a Unit from the Declarant, any person on becoming an Owner shall furnish to the Association a photocopy or a certified copy of the recorded instrument vesting that person with an ownership interest in the Unit. Such copy shall remain in the files of the Association. An Owner shall not be deemed to be in good standing and shall not be entitled to vote at any annual or special meeting of Owners unless this requirement is first satisfied.

8.02 Registration of Mailing Address.

If a Unit is owned by two or more Owners, such Owners shall designate one address as the registered address required by the Declaration. The registered address of an Owner or Owners shall be furnished to the secretary of the Association within ten days after transfer of

title, or after a change of address. Such registration shall be in written form and signed by all of the Owners of the Unit or by such persons as are authorized to represent the interests of all Owners of the Unit. If no address is registered or if all of the Owners cannot agree, then the address of the Unit shall be deemed the registered address of the Owner(s), and any notice shall be deemed duly given if delivered to the Unit.

8.03 Liens.

Any Owner who mortgages or grants a deed of trust covering his Unit shall give the Association written notice of the name and address of the Mortgagee and shall file true, correct, and complete copies of the note and security instrument with the Association.

8.04 Address of the Association.

The address of the Association shall be 175 East 400 South, Suite 160, Salt Lake City, Utah 84111. Such address may be changed from time to time upon written notice to all Owners and all listed Mortgagees.

**ARTICLE 9
SECURITY INTEREST IN MEMBERSHIP**

Owners shall have the right irrevocably to constitute and appoint a mortgagee their true and lawful attorney-in-fact to vote their Membership in the Association at any and all meetings of the Association and to vest in the Mortgagee any and all rights, privileges and powers that they have as Owners under the Articles and these Bylaws or by virtue of the Declaration. Unless otherwise expressly provided in such proxy, such proxy shall become effective upon the filing of notice by the Mortgagee with the secretary of the Association. A release of the Mortgage covering the subject Unit shall operate to revoke such proxy. Nothing herein contained shall be construed to relieve Owners, as mortgagors, of their duties and obligations as Owners or to impose upon the Mortgagee the duties and obligations of an Owner.

**ARTICLE 10
AMENDMENTS**

10.01 By Directors.

Except as limited by law, the Articles, the Declaration, or these Bylaws, the Management Committee shall have power to make, amend, and repeal the Bylaws of the Association at any regular meeting of the Management Committee or at any special meeting called for that purpose at which a quorum is represented. If, however, the Owners shall make, amend, or repeal any Bylaw, the Directors shall not thereafter amend the same in such manner as to defeat or impair the object of the Owners in taking such action.

10.02 By Owners.

Subject to any rights conferred upon first Mortgagees in the Declaration, the Owners may, by the vote of the holders of at least sixty-seven percent (67%) of the votes of the Owners, unless a greater percentage is expressly required by law, the Articles, the Declaration, or these Bylaws, make, alter, amend, or repeal the Bylaws of the Association at any annual meeting or at any special meeting called for that purpose at which a quorum shall be represented.

**ARTICLE 11
MISCELLANEOUS**

11.01 Fiscal Year.

The fiscal year of the Association shall be such as may from time to time be established by the Management Committee.

11.02 Other Provisions.

The Declaration contains certain other provisions relating to the administration of the Condominium Project, which provisions are hereby incorporated herein by reference.
