

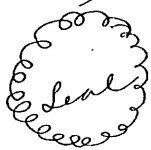

Haddock, his wife of Salt Lake County, Utah, grantors for the sum of Fifty (\$50.00) Dollars, paid to grantors by The Telluride Power Company, a Colorado corporation, hereby grant to said company, its successors and assigns, the right to erect and maintain one (1) line of poles and electric transmission circuits across the following described tract of land in Utah County Utah, to-wit:

The southwest one-quarter ($\frac{1}{4}$) of section numbered two (2), in township numbered five (5) south, of Range numbered one (1) west of Salt Lake Meridian; also the west one-half ($\frac{1}{2}$) of the north-west one-quarter ($\frac{1}{4}$) of said section.

This grant shall extend to and include a right of way over a strip of land, parallel to said pole line, as now located, fifteen feet wide, five feet on the east side and ten feet on the west side of the center of said line of poles, to be used by said grantee in the maintenance of said line of poles and circuits, and its right to enter said tract of land shall extend only to said strip, as above described; and said pole line and circuits shall not be changed from their present location.

The South-West one-quarter ($\frac{1}{4}$) of the South West one-quarter ($\frac{1}{4}$) of Section Numbered thirty-five (35), in township numbered four (4), South of Range numbered one (1) west of the Salt Lake Meridian; The grantee herein to maintain the said line where the same is, now constructed over and across the above described tract of land.

If in the future it becomes necessary for the grantee or its employees to replace a pole or make other actual repairs in said lines and the said grantee or its employees enter upon said tract and negligently trample down and destroy growing crops and trample down and destroy fences, then shall the owners of said lines pay unto the owners of said tract the actual value of such destroyed crops and replace said fences in as good condition as before said entry.
