SALT LAKE TERMINAL COMPANY, a Delaware corporation, doing business in the State of Utah, Grantor, hereby conveys, without warranty of title, express or implied, to PacifiCorp, an Oregon corporation, dba Utah Power & Light Company, whose principal place of business is located at 1407 West North Temple, Salt Lake City, Utah, its successors in interest and assigns, Grantee, for the sum of Ten (\$10.00) Dollars and other valuable consideration, a perpetual easement and right of way for the erection, operation, maintenance, repair, alteration, enlargement, inspection, relocation and replacement of electric transmission and distribution lines, communications circuits, fiber optic cables and associated facilities, and three existing poles, one new pole, three existing guy anchors and one new guy anchor, with the necessary guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said lines and circuits, on, over, under and across real property located in Davis County, Utah, described as follows:

A right of way 10 feet in width, being 5 feet on each side of the following described survey line:

Beginning at the south boundary fence of the Grantor's land, said south boundary fence also being the north right of way fence of 1100 North Street (a County road), at a point 759 feet south and 896 feet east, more or less, from the west one quarter corner of Section 36, T. 2N., R. 1W., S.L.M., thence N.0°07'E. 333 feet, thence S. 89°58'E. 278 feet, thence UNDERGROUND N.38°45'E. 232 feet, thence N.3°57'E. 24 feet to a new transformer pad on said land, and being in the NW¼ of the SW¼ and the S½ of the NW¼ of said Section 36.

A right of way 10 feet in width, being 5 feet on each side of the following described centerline:

Beginning at a pole in an existing powerline in the above described survey line on the Grantor's land at a point 426 feet south and 897 feet east, more or less, from the west one quarter corner of Section 36, T. 2N., R. 1W., S.L.M., thence N.89°58'W. 42 feet on said land and being in the SW¼ of the NW¼ of said Section 36.

Beginning at a new pole in the above described survey line on the Grantor's land at a point 426 feet south and 1175 feet east, more or less, from the west one quarter corner of Section 36, T. 2N., R. 1W., S.L.M., thence S.89°58'E. 45 feet on said land and being in the SE¼ of the NW¼ of said Section 36.

This easement is granted in accord with and supplements a prior easement dated October 21, 1952 and recorded on the 27th day of July, 1953 in the office of the County Recorder of Davis County, Utah, in Book 54 at Page 96.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the use, occupation, or enjoyment of this easement.

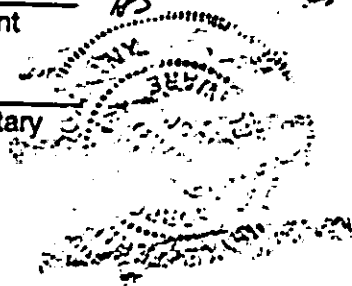
