NOW THEREFORE, it is agreed by and between the parties hereto, that the hereinabove described access opening are hereby released and relinquished, and shall be forever closed to the second party, its successors or assigns. In exchange for said closing the first party hereby grants to the second party, its successors or assigns, the right of access to the nearest roadway of said highway over and across said northerly L/A right-of-way line for one (1) fifty (50) -foot section, which said section centers at a point directly opposite Highway Engineer Station 100+54[±] and the construction will be the responsibility of the second party through its authorities, rights, and powers.

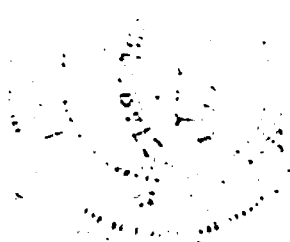
