In order to comply with Salt Lake County addressing standards and to recognize the addressing residents on the street are using for the official street name, the street name Lone Pine Dr should be officially changed and corrected on the county street file to Adonis Dr. Adonis Dr will officially be assigned from the intersection of 4005 E and 4255 S to 3770 E and 4505 S. This street name change is necessary for Salt Lake County Emergency Services to properly locate the residents along this street.
