 CONVEYS AND WARRANTS to the SOUTH JORDAN CITY, at 1600 West Towne Center
 Dr. (10610 S.) South Jordan, Utah 84095, Grantee, for the sum of
ten Dollars,
 and other good and valuable considerations, the following described parcel of land in Salt
 Lake County, State of Utah, to-wit:

A parcel of land in fee, for the widening of the existing 1300 West Street known as
 Project No. LC35(1), being part of an entire tract of property, situate in NW¼SW¼ of
 Section 23, T.3S., R.1W., Salt Lake Base and Meridian. The boundaries of said parcel of
 land are described as follows:

Beginning at the intersection of the Southerly boundary line of said entire tract and
 the Easterly right of way of said project, which point is 1,063.84 feet S.00°06'55"W. along
 the Section line from the West Quarter corner of said Section 23; and running thence East
 42.50 feet along the Southerly boundary line of said entire tract to a point 42.50 feet
 perpendicularly distant Easterly from the center line of said project, opposite approximate
 Engineers Station 1015+96.41; thence N.00°06'55"E. 93.00 feet parallel to said project
 center line; thence West 42.50 feet along the Northerly boundary line of said entire tract;
 thence S.00°06'55"W. 93.00 feet along said Section line to the point of beginning.

The above described parcel of land contains 3,952 square feet in area or 0.091 acres
 of which 1,962 square feet or 0.045 acre is now occupied by the existing 1300 West Street
 right of way, Balance 1,990 square feet or 0.046 acre.

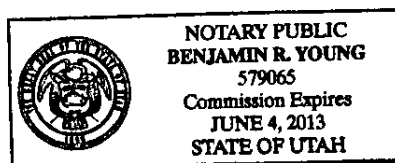
