ASSIGNMENT OF OIL AND GAS LEASES

(With Reservation of Overriding Royalty Interest)

WHEREAS, ODESSA NATURAL CORPORATION, a Texas corporation whose mailing address is Post Office Box 3908, Odessa, Texas 79760, is the owner and holder of certain interests in and to certain oil and gas leases (hereinafter sometimes referred to as "Said Leases") in Utah County, Utah, and

WHEREAS, it is the desire of ODESSA NATURAL CORPORATION to sell, assign and convey all of its interest in and to Said Leases to EL PASO EXPLORATION COMPANY, whose mailing address is Post Office Box 1492, El Paso, Texas 79978.

NOW, THEREFORE, ODESSA NATURAL CORPORATION (hereinafter referred to as Assignor), for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, and subject to the hereinafter setforth overriding royalty reservation, does hereby assign, transfer and convey unto EL PASO EXPLORATION COMPANY (hereinafter referred to as Assignee), all of Assignor's right, title and interest in and to those certain oil and gas leases in Utah County, Utah, insofar and only insofar as Said Leases cover the lands described in Exhibit "A" attached hereto and made a part hereof.

The provisions of this Assignment shall be construed as covenants running with the land and shall be binding upon and inure to the benefit of the parties hereto, their successors and assigns. This Assignment is made subject to all the terms, conditions and reservations setforth in the original leases and any and all intervening assignments of such leases or interest therein, including but not limited to reservations of overriding royalty and production payments together with any and all reassignment obligations heretofore imposed and to all of the terms and conditions of any and all valid and subsisting agreements to which the leasehold hereby assigned is presently committed.

The Assignor hereby expressly excepts, reserves and retains unto itself an overriding royalty equal to one-eighth of eight-eighths (1/8th of 8/8ths) of all oil, gas and casinghead gas produced, saved and marketed from Said Lands under the provisions of the aforesaid leases, or any extensions or renewals thereof, as an overriding royalty, free and clear of any cost and expense of the development and operation thereof, excepting taxes applicable to said interest and the production therefrom. Said overriding royalty is a burden solely upon the interest herein assigned and shall never be merged with but shall remain separate from any working interest which Assignor may now own or which it may hereinafter acquire in Said Leases. It is understood and agreed between the parties that said overriding royalty shall be proportionately reduced to the oil and gas leasehold interest herein assigned and shall be subject to further proportionate reduction in the event Said Leases

cover less than the full and entire mineral estate in the leased premises. The overriding royalty herein reserved by Assignor is in addition to and does not include any previously created burdens upon the leasehold interest hereby assigned.

Assignee accepts this assignment with the express understanding that its provisions will apply to any renewals, exchanges, extensions or alterations of the original leases, in whole or in part; and that if Assignee, its successors or assigns elect to surrender any part of the original leases, or any renewals, exchanges, extensions or alterations thereof, such surrender will be made to Assignor at least thirty (30) days in advance of the next anniversary of the leases. Any reassignment under the terms of this paragraph shall be free and clear of all burdens, encumbrances or outstanding interest other than those existing on the date hereof.

This Assignment is made without warranty of any kind, either express or implied.
