CONVEYANCE OF PERPETUAL ROAD ACCESS EASEMENT

(Road Easement)

THIS CONVEYANCE OF A PERPETUAL ROAD ACCESS EASEMENT, dated as of the day of Modern been, 2018 (hereinafter referred to as "Conveyance"), by and between BOYDEN FARMS, LLC, a Utah Limited Liability Company, and WOHALI PARTNERS, LLC, a Utah Limited Liability Company, (hereinafter referred to as GRANTORS) and MOUNTAIN LAND AND LIVESTOCK, LLC, a Utah Limited Liability Company, and LEWIS PEAK COMMUNICATIONS, INC., a Utah Corporation, (hereafter referred to as GRANTEES).

WITNESSETH:

WHEREAS, certain real properties owned by the Grantees have been serviced for many years by an access road commonly known as the Franklin Canyon Road; and

WHEREAS, the intent of this conveyance is to memorialize the rights of the Grantees to the private and unrestricted use of a private, surveyed road granting them access to their respective real properties without resort to litigation.

NOW THEREFORE, in consideration of the mutual covenants and agreements herein set forth, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged collectively by the Grantors, Grantors hereby grant, sell and convey to the Grantees, their successors in interest, heirs and assigns a perpetual road easement 24 feet in width over and across the real property of Grantors as more fully set out and described in Exhibits A and B, attached hereto and incorporated herein by this reference for the purpose of providing access, both ingress and egress, for Grantees to their respective real properties upon the following terms and conditions:

- 1. This easement is granted without restriction as to use be it vehicular, pedestrian, or equestrian, and shall include, but not be limited to, agricultural, commercial, recreational, hunting, fishing, logging, fire suppression, weed control, grazing, and transportation and trailing of all types of livestock.
- 2. The centerline of the easement is described in Exhibit A, and shall extend 12 feet on either side of said centerline making the total width of the easement 24 feet.
- 3. Grantors have the right to fence Grantors' real property adjacent to the easement, and to install necessary gates or cattle guards across the easement providing the gates and/or cattle guards are 16 feet wide. If Grantors lock any gates, Grantors shall provide keys to Grantees to allow Grantees unimpeded passage on the easement.

- 4. Grantees are given no rights beyond the boundaries of the easement and may not travel across property adjacent to the easement without permission of the landowner of the adjacent property
- 5. Grantees shall be responsible for its use of the road within the easement and the use of such road by any of its agents or invitees. Grantees shall hold the Grantors harmless and shall indemnify Grantors for any and all liability in connection with the Grantees, its agents or invitees claim of liability or loss from personal injury or property damage resulting from or arising out of their use of such road. In the event that such road is damaged by a Grantees, its agents or invitees of the Grantees, Grantees shall be responsible for the immediate repair of that damage and restoration of the easement to its original condition, or as close thereto as possible.
- 6. All of the covenants herein contained shall be binding upon and inure to the benefit of the Grantees, their respective heirs, personal representatives, successors in interest, agents and assigns.
