The Trust Deed covers the following described real property situated in Salt Lake County, Utah:

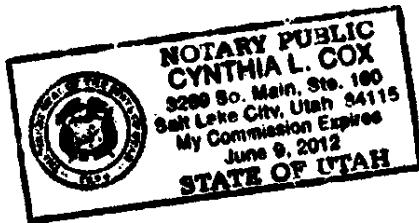
