- 1. Defined Terms and Status of Resitals. Capitalized terms used and not otherwise defined in this Eighth Amendment shall have the meaning or meanings given to them in the Declaration. The Recitals set forth above shall constitute a portion of the terms of this Eighth Amendment.
- 2. <u>Amendment to Exhibit A to Declaration</u>. Exhibit Actorbe Declaration is hereby deleted in its entirety and replaced with <u>Exhibit "A"</u> which is attached hereto and incorporated herein by this reference.
- 3. Addition of Private Driveway Easement Definition. The following definition is hereby added to Section 8.11.2 of the Declaration:
 - "8.15.2 Private Driveway Easement" means those areas depicted on the Final Subdivision Plats as Private Driveway Easements, and such exclusive easements shall be for the benefit of those Owners for which such easement is granted and shall be operated, maintained, repaired, or replaced by such Owners."
- 4. <u>Declaration Remains in Effect</u>. This Eighth Amendment shall be considered supplemental to the Declaration. Except as expressly amended by the foregoing, the Declaration shall remain in full force and effect and shall not be canceled suspended or otherwise abrogated by the recording of this Eighth Amendment.
- 5. Declarant Rights. Declarant shall retain all rights of Declarant as set forth in the Declaration and this Eighth Amendment shall neither amend nor abrogate such rights.
