Trustor agrees to pay all taxes and assessments on the above property, to pay all charges and assessments on water or water stack used on or with said property, not commit waste, to maintain adequate fire insurance on improvements on said property, to pay all costs and expenses of collection including Trustee's and attorney's fees in event of default in payment of the indebtedness secured hereby and to pay reasonable Trustee's fees for any of the services performed by Trustee hereunder, including a reconveyance hereof.


