

The Court notes that today's hearing is to reschedule a trial date.
Mr. Duffin addressed the Court in regards to concerns about calling experts and witnesses.

Mr. Duffin further informed the Court that a date for exchange of witnesses and exhibits had been set prior to the trial date and nothing had been received from the defendants.

The Court questioned Mr. Rodriguez on why he failed to comply with the order of the Court in regards to exchanging of witnesses and exhibits.

Mr. Rodriguez informed the Court that he would have no other witnesses beside himself for the trial.

The Court questioned Mr. Rodriguez on if he would be presenting evidence at the trial. Mr. Rodriguez stated he had photos that he would be using as exhibits.
