DRINKING WATER SOURCE PROTECTION EASEMENT

Hidden Valley Country Club, a Utah Corporation, **Grantor**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby grants and conveys to **Draper Irrigation Company, Inc.**, a Utah non-profit corporation, **Grantee**, a perpetual drinking water source protection easement ("Easement") as more fully described below upon the following described tract of real property to the extent it is owned by Grantor, said tract being located in Salt Lake County, State of Utah:

See the attached legal description and map of a one hundred (100) foot radius circle around the Grantee's proposed production culinary water well, which legal description and map are expressly incorporated herein by this reference.

This Easement covers prohibits certain activities that could contaminate the subject drinking water well as set forth in Utah Administrative Code Regulation R309-600-6(n), -6(t) and -6(u) (and any amendments thereto) within the tract covered by this Easement, including, for example, activities such as the storage of large volumes of chemicals, construction of commercial animal feed yards, construction of waste disposal facilities or garbage dumps, and construction of large volume underground fuel storage tanks.

This Easement runs with the land and automatically binds and inures to the benefit of the transferees and successors of each of the parties hereto.


