From and after the recordation of this Supplement, the Additional Lot shall be held, transferred, sold, conveyed and occupied subject to the Declaration, including, without limitation, all covenants, restrictions, easements, conditions, charges, and liens set forth in the Declaration. In addition, the Additional Lot shall be subject to the governance of the Soda Row Townhome Association, Inc., a Utah nonprofit corporation (the "Association"), as more particularly described in the Declaration. Owner and Lender hereby consent to the submission of the Additional Lot to the Declaration and to the governance of the Association as provided herein.
- 3. <u>Full Force and Effect</u>. The Declaration, as supplemented hereby, shall remain in full force and effect.
- 4. <u>Incorporation by Reference</u>. The Recitals and Exhibit to this Supplement are hereby incorporated into this Supplement by this reference.
