

CONVEYANCE OF EASEMENT

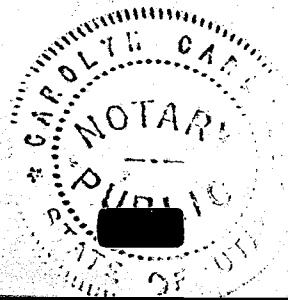
