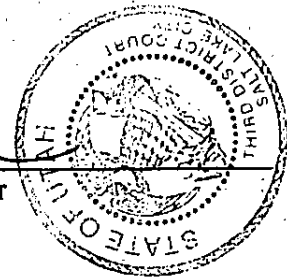
with interest accruing on the Total Judgment from December 20, 2011 at the rate of 8.75% until paid in full.

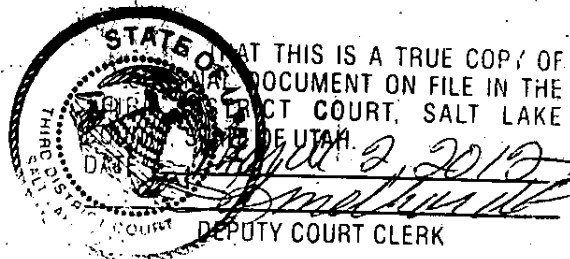
