AN ORDINANCE

AN ORDINANCE VACATING ALLEYS
in Blocks 1 and 3, Fairmont Subdivision,
being a part of the Southwest Quarter
of Northeast Quarter of Section 22,
T. 1 S., R. 1 E., S. L. B. & M., in Salt
Lake City, Utah.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That alleys in Blocks 1
and 3, Fairmont Subdivision, being a part
of the Southwest Quarter of Northeast
Quarter of Section 22, T. 1 S., R. 1 E.,
S. L. B. & M., in Salt Lake City, Utah,
more particularly described as follows:

Beginning at the northeast corner
of Lot 1, Block 1, Fairmont Sub.,
being a part of the Southwest Quarter
of Northeast Quarter of Section 22,
T. 1 S., R. 1 E., S. L. B. & M., running
thence South 126.00 ft., thence East
17.00 ft., thence North 39 deg. 11 min.
40 sec. West 7.74 ft., thence North
120.00 ft., thence East 120.00 ft. to the
point of beginning.

Also beginning at the Northwest corner
of Lot 1, Block 1, Fairmont Sub.,
running thence South 126.00 ft., thence
East 7.74 ft., thence North 39 deg. 11 min.
40 sec. West 7.74 ft., thence North
120.00 ft., thence East 120.00 ft. to the
point of beginning.

Beginning at the Northeast corner
of Lot 1, Block 3, Fairmont Sub.,
being a part of the Southwest Quarter
of Northeast Quarter, Section 22,
T. 1 S., R. 1 E., S. L. B. & M., running
thence South 126.00 ft., thence East
17.00 ft., thence North 39 deg. 11 min.
40 sec. West 7.74 ft., thence North
120.00 ft., thence West 120.00 ft. to the
point of beginning.

Also beginning at the Northwest corner
of Lot 32, said Block 1, Fairmont Sub.,
running thence South 126.00 ft., thence
East 7.74 ft., thence North 39 deg. 11 min.
40 sec. West 120.00 ft., thence North
120.00 ft., thence East 120.00 ft. to the
point of beginning.

Also beginning at the Northwest corner
of Lot 32, said Block 3, Fairmont Sub.,
running thence South 126.00 ft., thence
East 7.74 ft., thence North 39 deg. 11 min.
40 sec. West 120.00 ft., thence North
120.00 ft., thence East 120.00 ft. to the
point of beginning.

he and the same are hereby vacated and
declared no longer to be public property
for use as streets, avenues, alleys
or pedestrian walk.

Said vacation is made expressly sub-
ject to all existing rights of way and
easements of all public utilities of any
and every description now or hereafter in-
tended, under or over the surface of the
above described property and also sub-
ject to the right of entry thereon for
the purpose of inspecting, maintaining,
repairing, replacing, removing, altering or
rerouting said utilities and all of
them.

SECTION 2. In the opinion of the
Board of Commissioners, it is necessary
to the peace, health and safety of the
inhabitants of Salt Lake City that this
ordinance shall become effective im-
mediately.

SECTION 3. This ordinance shall
take effect upon its first publication.
