EASEMENT

Located in the _____ Quarter of Section ____, Township ____, Range ____, Salt Lake Base and Meridian, U.S. Survey. Harvest Hills Planned Unit Development, City of Saratoga Springs, Utah County, Utah. Lot numbers 122, 123, 124, 125, 126, 127, 128, and 129.

For the sum of Ten Dollars (\$10.00) and other good and valuable considerations, the receipt and sufficiency of which is hereby acknowledged, the undersigned GRANTOR(S) hereby grant, convey, sell, and set over unto the Harvest Hills Master Home Owners Association, a Utah non-profit corporation, hereinafter referred to as GRANTEE, its successors and assigns, a perpetual right-of-way and easement to lay, maintain, operate, repair, inspect, protect, install, remove and replace driveways, mailbox structures, utility pipe, lines, and other utility transmission and distribution structures and facilities and associated improvements, hereinafter called FACILITIES, said right-of-way and easement, being situated in the Harvest Hills Planned Unit Development, the City of Saratoga Springs, Utah County, State of Utah, over and through parcels of the GRANTOR'S land as described in Exhibit A which is attached hereto and incorporated herewith by this reference.

TO HAVE AND TO HOLD the same unto the GRANTEE, its successors and assigns, so long as such FACILITIES shall be maintained, with the right of ingress and egress in the GRANTEE, its officers, employees, representatives, agents, and assigns to enter upon the above described property with such equipment as is necessary to install, maintain, operate, repair, inspect, protect, remove and replace the FACILITIES. During construction periods, GRANTEE and its contractors may use such portion of GRANTOR'S property along and adjacent to the easement as may be reasonably necessary in connection with the construction or repair of the FACILITIES. The contractor performing the work shall restore all property through which the work traverses, to as near its original conditions as is reasonably possible. GRANTOR(S) shall have the right to use above described premises except for the purpose for which this right-of-way and easement is granted to the GRANTEE, provided such use shall not interfere with the FACILITIES or with any rights granted to the GRANTEE hereunder.

GRANTOR(S) shall not build or construct or permit to be built or constructed any building or other improvement, over or across this right-of-way and easement, nor change the contour thereof without the written consent of GRANTEE. This right-of-way and easement

grant shall be binding upon and inure to the benefit of the successors and assigns of the GRANTOR(S) and the successors and assigns of the GRANTEE, and may be assigned in whole or in part by GRANTEE.

IN WITNESS WHEREOF, the GRANTOR(S) have executed their right-of-way and easement this 27 day of Sept., 2002.




