## RELEASE AND QUITCLAIM OF EASEMENT

THIS RELEASE AND QUITCLAIM, made this day of , 2012, by and between UNION PACIFIC RAILROAD COMPANY, a Delaware corporation, Grantor, and SLHNET INVESTMENTS, L.C., a Utah limited liability company, Grantee, WITNESSETH:

#### RECITALS

WHEREAS, by Fiber Facilities Easement Deed and Agreement dated December 22, 1998, and recorded on December 24, 1998, at Book 8208, Page 2606, Instrument No. 7202241, Official Records of Salt Lake County, Utah (the "1998 Deed"), Gateway Associates, Ltd. granted to Grantor, its successors and assigns, a perpetual non-exclusive easement ("Easement") upon, over, under and across the property in the City and County of Salt Lake, Utah, described in **Exhibit A** attached hereto and hereby made a part hereof ("Easement Area") to construct, reconstruct, rebuild, reinstall, operate and maintain underground fiber optics communication cable and appurtenant facilities, together with the right of reasonable access, ingress and egress to and from the Easement Area for the purposes of this Easement; and

WHEREAS, Grantee desires the cancellation and release of the Easement granted to Grantor in the 1998 Deed upon, over, under and across the Easement Area, and Grantor is willing that such easement rights over, under and across the Easement Area be cancelled and released.

NOW, THEREFORE, Grantor, in consideration of the premises and in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration to it in hand paid, the receipt of which is hereby confessed and acknowledged, for itself, its successors and assigns, does hereby REMISE, RELEASE AND QUITCLAIM to Grantee, its successors and assigns, forever, all of its right, title, interest, estate, claim and demand, both at law and in equity, which it has by reason of that Easement in and to the land described in **Exhibit A**.
