RESERVING AND WITHHOLDING THEREFROM ALL MINERAL AND OIL RIGHTS AND
ALL EXISTING RIGHTS-OF-WAY.

This deed is made under the authority of Section 80-10-68 of Utah Code annotated, 1943,
and in pursuance of an order by the Board of County Commissioners of said Iron County, made the
13th day of January, 19 58. Vesting in the purchaser all of the title of the
state, county and of each city, town, school or other taxing district interested in said real estate
