The UTAH DEPARTMENT OF TRANSPORTATION, by its duly appointed Director of Right of Way, Grantor, of Salt Lake City, County of Salt Lake, State of Utah, hereby QUIT CLAIMS to HERRIMAN CITY, Grantee, at 13011 South Pioneer Street, City of Herriman, County of Salt Lake, State of Utah, Zip 84096, for the sum of Ten Dollars (\$10.00), and other good and valuable considerations, the following described tract of land in Salt Lake County, State of Utah, to-wit:

A tract of land, situate in Lot 8 of Section 7, T. 4 S., R. 1 W., S.L.B. & M. The boundaries of said tract of land are described as follows:


Beginning at a point in a southeasterly highway limited-access line of UDOT Project MP-182(6), designated as Point "A", which point is 867.08 ft. N. 0°28'16" E. along the section line and 565.77 ft. WEST from the Southeast Corner of said Section 7; and running thence along said southeasterly limited-access line the following three courses: 1) S. 77°13'46" W. 33.38 ft.; 2) S. 38°03'22" W. 167.00 ft.; 3) S. 40°24'59" W. 107.21 ft. to the end of said southeasterly limited-access line to a point designated as Point "B"; thence S. 40°24'59" W. 34.87 ft.; thence N. 52°01'18" W. 136.00 ft.; thence N. 35°57'20" E. 35.05 ft. to the beginning of the northwesterly limited-access line to a point designated as Point "C"; thence along said northwesterly limited-access line the following two courses: 1) N. 35°57'20" E. 293.25 ft.; 2) N. 5°56'52" E. 46.22 ft. to a point designated as Point "D"; thence S. 42°46'40" E. 202.12 ft. to the point of beginning as shown on the official maps of said project on file in the office of the Utah Department of Transportation. The above described tract of land contains 52,328 square feet in area or 1.201 acres, more or less.

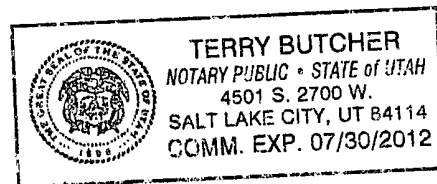

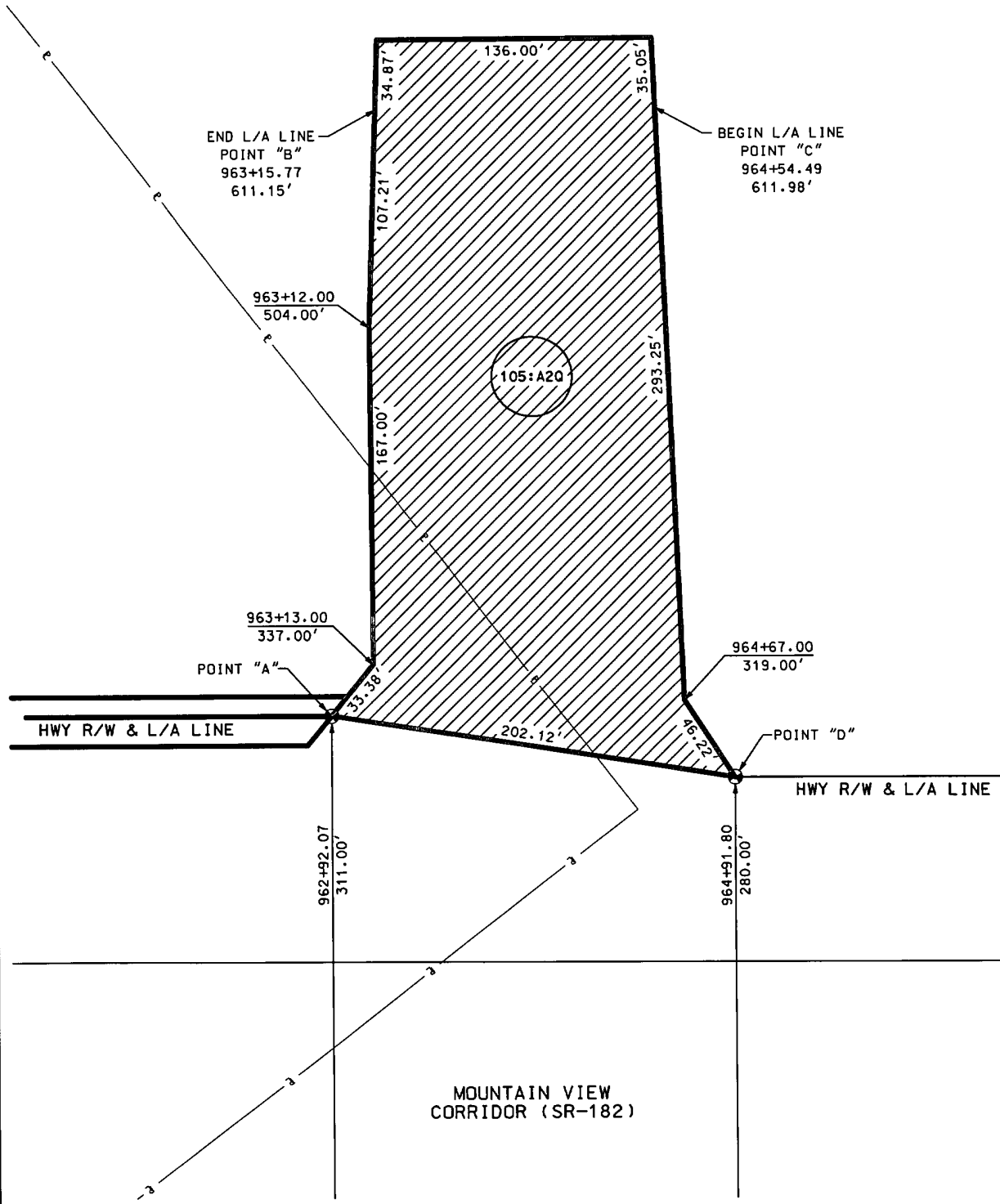
