ABSTRACT

SPECIAL WARRANTY DEED

UNITED PARK CITY MINES COMPANY, a Delaware corporation, Grantor, hereby conveys and warrants against all persons claiming by, through or under it, but not otherwise, to GREATER PARK CITY COMPANY, a Utah corporation, Grantee, for the sum of Ten Dollars (\$10.00) and other valuable consideration, the following described tract of land in Summit County, State of Utah:

Beginning at a point East 1444.035 feet and South 1637.98 feet from the West quarter corner of Section 9, Township 2 South, Range 4 East, Salt Lake Base and Meridian, said point being on a curve to the right, the radius point of which is South 11°40'50" East 200.00 feet; and running thence Northeasterly along the arc of said curve 26.81 feet to a point of tangency; thence North 86°00' East 322.72 feet to a point of a 500.00 foot radius curve to the right; thence Easterly along the arc of said curve 54.53 feet to a point of tangency; thence South 87°45'03" East 23.51 feet; thence South 2°14'57" West 300 feet; thence North 87°45'03" West 270.00 feet; thence North 23°55'37" West 139.80 feet; thence South 65°28'03" West 25.54 feet; thence North 24°00' West 159.72 feet to the point of beginning.

Excepting and reserving to Grantor, its successors and assigns, all ores and minerals situated in, upon or under the above described tract of land, together with all rights in connection with or relative to the mining, removal or sale of the same (but not including the right to enter upon the surface of the premises).

Subject to:

1. Taxes for the year 1972 which are now a lien but are not yet due and payable.
2. A Mortgage Deed given to secure a note bearing even date thereof, with interest thereon payable as therein provided, said Mortgage being in the amount of \$1,232,000.00, dated November 28, 1962, recorded December 4, 1962, as Entry No. 96243 in Book M-5 at Page 563 of Official Records, and




