BASTIAN, his wife, grantees of Midvale, Salt Lake County, Utah, for the sum of Ten and no/100 Dollars (and other good and valuable consideration, the following described tract of land in Salt Lake County, Utah, to-wit:-

Commencing 80 rods North from the Southeast corner of Section 26, Township 3 South, Range 2 West, Salt Lake Meridian and running thence North 80 rods; thence West 140 rods; thence South 93-1/3 rods; thence East 60 rods; thence North 13-1/5 rods; thence East 80 rods to the place of beginning.

Also: the South 1115 feet of the Southeast quarter of the Northwest quarter of Section 26, Township 3 South, Range 2 West, Salt Lake Base and Meridian,

Also the West 16 rods of the South 1115 feet of the Northeast quarter of Section 26, Township 3 South, Range 2 West, Salt Lake Base and Meridian.

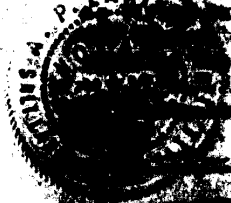
