AMENDMENT TO THE CONDOMINIUM DECLARATION

- B. This amendment shall be binding against the property described in the Declaration and any annexation or supplement thereto, described as follows:

All Units and Common Area, CENTURY VILLA CONDOMINIUM, according to the plat(s) thereof as recorded in the office of the Salt Lake County Recorder.

First Parcel # 16-30-454-001

- C. Pursuant to Article XXVII of the Declaration, the affirmative vote or approval and consent of not less than 66.66 percent of the undivided interest in the Common Areas and Facilities was obtained to adopt this amendment.
- NOW, THEREFORE, The Association hereby amends Article VII, Section (b)(6) of the Declaration to read as follows:
- (6) A. No pets or animals shall be kept within any Unit which is being rented ("rented" in this subsection (6) means the use or occupancy of a Unit for a specific or indefinite term with rent stated on a periodic basis, in exchange for the payment of rent (money, property or other goods or services of value)).
- B. No more than one pet shall be kept within a Unit and such animal shall not exceed 25 pounds in weight.

C. No pets or animals of any kind shall be allowed, kept, bred or raised in any Unit or on any of the Common Areas in the Project, unless on leash, held by an owner, or in its owner's arms.
