AMENDMENT TO THE BYLAWS OF RIVERWALK EXECUTIVE HOMEOWNERS ASSOCIATION

This Amendment to the Bylaws is executed on the date set forth below by Riverwalk Executive Homeowners Association ("Association") by and through its Board of Directors.

RECITALS

- A. Real property in Salt Lake County, Utah, known as The Village at Riverwalk P.U.D. was subjected to covenants, conditions, and restrictions recorded as Entry No. 9887649, in the Salt Lake County Recorder's Office, Utah ("Declaration"). The Declaration required the formation of an association of homeowners called Riverwalk Executive Homeowners Association;
- B. Bylaws for the Association were adopted October 23, 2006, a copy of which are attached hereto as Exhibit "B".
- C. This amendment shall be binding against the property described in Exhibit "A" and the Declaration as belonging in the Riverwalk Executive Homeowners Association, any amendment, annexation, or supplement thereto;
- D. This amendment is intended to facilitate the efficient administration of the Association by allowing the Board to replace Directors who resign, die, or are removed prior to the end of their term;
- E. Under Bylaw Article X, Section 10.01, this amendment has been approved unanimously by the Directors at a meeting called for the purpose of amending the Bylaws at which a quorum was present;

NOW, THEREFORE, the Association hereby amends the Bylaws as follows:

Bylaw Article VI, Section 6.04(ii) is amended in its entirety to read as follows:

ii. A vacancy on the Board created by the removal, resignation, or death of a Director appointed by the Board or elected by the Executive Lot Owners shall be filled by a Director appointed by the Board, regardless of whether a quorum of the Board may be established because of the vacancy. If the vacancy occurs within 3 months of the next election of Directors by the Owners, the Board may elect to leave the vacancy open until such election. If the vacancy is left open until the next election, a quorum of the Board shall be a majority of the remaining Directors.
