GRANT OF RIGHT-OF-WAY *D16-376-30.*

Salt Lake County, a county of the State of Utah, Grantor,

hereby quit claims to Mountain Fuel Supply Company, a corporation of the State of Utah, Grantee, pursuant to a Resolution of the Board of County Commissioners at its meeting held June 22, 1949, a perpetual right-of-way and easement, with the right of egress and ingress for the purpose of constructing, maintaining and operating a pipe line for the transportation of natural gas. Said additional pipe line to be approximately parallel to and about 9 feet distant from the original pipe line right-of-way for which was granted by Salt Lake County under date of January 4, 1929, and to be buried between two and three feet beneath the surface and so covered as to restore the surface to its normal condition.

Said line to be through, over and across portions of Sections 33 and 34, Township 1 North, Range 2 East, and Sections 1, 2, and 3, Township 1 South, Range 2 East, and Sections 11 and 12, Township 1 South, Range 1 East, Salt Lake Base and Meridian.

The said Grantee, by the acceptance of this grant hereby undertakes and agrees to hold Salt Lake County free from any damage or claim of damage and clear of any liability by virtue of the construction, operation and maintenance of said pipe line over and across lands belonging to Salt Lake County.
